Anubha Soni, w/o late Shri Sanjeev Soni, r/o AA-114, 2nd Floor, Shalimar Bagh, Delhi-110088, alleging medical negligence on the part of Dr. Ankur Garg, Dr. Sanjay Singh of B.L. Kapoor Hospital, Pusa Road, New Delhi-110005, in the treatment of complainant's

- husband Shri Sanjeev Soni, resulting in his death, was confirmed by the Delhi Medical Council.
- (ii) The Order of the Executive Committee in complaint No. 3472 of Shri Vishal Mahajan S/o Shri Mulk Raj Mahajan r/o Kothi No. 131, Phase-1, Mohali, forwarded by National Medical Commission, alleging medical negligence on part of Dr. Mohit Singla, in the treatment of complainant's mother Smt. Chanchal Mahajan, resulting in her death on 19.5.2021, was confirmed by the Delhi Medical Council.
- (iii) The Order of the Executive Committee in complaint No. 3585- a representation from Police Station, Preet Vihar, Delhi-110092, seeking medical opinion on a complaint of Shri Deepak Gupta (FIR No.159/20), B-8, Preet Vihar, East Delhi-110092, allegedly due to medical negligence on the part of doctors of Metro Hospital and Cancer Institute, Preet Vihar, Delhi-110092 in the treatment administered to complainant's wife Smt Vineeta Gupta, was confirmed by the Delhi Medical Council.
- (iv) The Order of the Executive Committee in complaint No. 2977 of Shri Rajneesh Kumar Khetan, Peerpanti Bazar, Bhagalpur, forwarded by the Directorate General of Health Services, Govt. of NCT. of Delhi, alleging medical negligence on the part of doctors of Indraprastha Apollo Hospital, Sarita Vihar, New Delhi, in the treatment administered to Shri Rajesh Kumar, was confirmed by the Delhi Medical Council.
- (v) The Order of the Executive Committee in complaint No. 3261- a representation from Police Station Dabri, New Delhi, seeking medical opinion in respect of death of Miss. Bhavana d/o Shri Joginder Singh, allegedly due to medical negligence in the treatment administered at Suman Super Speciality Hospital, Plot No.14, Pocket No.-4, Binda Pur (Near C-1 Janak Puri), New Delhi-110059, resulting in her death on 26.03.2019 at Mata Chanan Devi Hospital where she was subsequently treated, was confirmed by the Delhi Medical Council.
- (vi) The Order of the Executive Committee in complaint No. 3191 of Ms. Kriti Vaswani, r/o F-14/4, New Delhi, Model Town-2, Delhi-110009, alleging medical negligence on the part of Dr. Uma Vaidyanathan and Max Super Speciality Hospital, Shalimar Bagh, FC-50, C & D Block, Shalimar Bagh, New Delhi-110088, in the treatment administered to the complainant at Max Super Speciality Hospital, Shalimar Bagh, New Delhi-110088, was confirmed by the Delhi Medical Council.

- (vii) The Order of the Disciplinary Committee in complaint No. 2794 of Shri Hraadyesh r/o S-55, SF Greater Kailash-2, New Delhi-110048, alleging medical negligence and professional misconduct in the treatment of the complainant's wife and her twin baby at Fortis La Famme, Greater Kailash New Delhi and Indraprastha Apollo Hospital, was confirmed by the Delhi Medical Council.

The Council observed that the matter be referred back to the Disciplinary Committee for re-consideration on the following issues -:

- (a) Which records required to be maintained during the dialysis, be specified, which were not kept in the present case?
- (b) Whether Dr. Ajeet Kumar Roy had adequate training to manage ICU independently, be looked into by the Disciplinary Committee.

Once the Disciplinary Committee has determined the aforementioned issues, the matter be placed before the Council for consideration/confirmation.

- (ix) The Order of the Disciplinary Committee in complaint No. 1898 of Shri Rakesh Babu, r/o- C-3/33, Plot No.10, Himalyan Residency, Sector-22, Dwarka, New Delhi-110077, alleging medical negligence on the part of the doctors of Institute of Liver & Biliary Sciences, D-1, Vasant Kunj, New Delhi, in the treatment administered to the complainant's wife late Smt. Sneh Lata, resulting in her death, was confirmed by the Delhi Medical Council.
- (x) The Order of the Disciplinary Committee in complaint No. 3174- a representation from Police Station, Tigri, South Distt., New Delhi, seeking medical opinion in respect of death of Smt. Sushila Mehra w/o Shri Sher Singh Mehra, r/o House No. 2650/95, Gali No.03, L-1st, Sangam Vihar, New Delhi, allegedly due to medical

negligence on the part of the doctors of Batra Hospital & Medical Research Centre, 1 Tughlakabad Institutional Area, Mehrauli Badarpur Road, New Delhi-110062, in the treatment of Smt. Sushila Mehra, resulting in her death on 18.07.2019, was confirmed by the Delhi Medical Council.

(xi) The Order of the Disciplinary Committee in complaint No. 1919 of Shri Amitabh Singh, s/o late Shri Cyril North, r/o- N8/180B-8-B, Rajendra Vihar, Newada, Sunderpur, Varnasi (U.P.) forwarded by the Directorate General of Health Services, Govt. of NCT. of Delhi, alleging medical negligence on the part of doctors of Max Super Specialty Hospital, 108A, Indraprastha Extension, Patparganj, New Delhi-110092, in the treatment administered to the complainant at Max Super Specialty Hospital, was taken up for confirmation before the Delhi Medical Council.

Whilst confirming the Order of the Disciplinary Committee, the Council observed that in this case, it is the clinical judgment of a surgeon to do arterial anastomosis and the same is an accepted professional practicies in such case; hence, the punishment of warning awarded by the Disciplinary Committee to Dr. P.B. Singh (Dr. Pratap Bahadur Singh, Delhi Medical Council Registration No. 47549), is not warranted.

This observation is to be incorporated in the final Order to be issued. The Order of the Disciplinary Committee stands modified to this extent and the modified Order is confirmed.

(xii) The Order of the Disciplinary Committee in complaint No. 2466 of Shri Balbir Singh, r/o- 923, Tilak Gali, Kashmiri Gate, Delhi, forwarded by the Medical Council of India, alleging professional misconduct and medical negligence on the part of Dr. Sadhna Singhal of Muni Maya Ram Jain Hospital, Pitampura, Delhi, in the treatment administered to the complainant at Muni Maya Ram Jain Hospital, was confirmed by the Delhi Medical Council.

The Council further confirmed the punishment of warning awarded by the Disciplinary Committee to Dr. Seema Mishra (Delhi Medical Council Registration No.941) with a direction that she should undergo twelve hours of Continuing Medical Education (C.M.E.) on the subject "Medico Legal Cases", within a period of three

months from the date of the Order and submit a compliance report to this effect to the Delhi Medical Council.

The Council further observed that the Order directing the issuance of warning shall come into effect after 60 days from the date of the Order.

This observation is to be incorporated in the final Order to be issued. The Order of the Disciplinary Committee stands modified to this extent and the modified Order is confirmed.

- The Order of the Disciplinary Committee in complaint No. 3241 of Smt Pragya, r/o-337/21 C, Master Mohalla Tugalkabaad Village, New Delhi-110044, alleging medical negligence on the part of doctors of Aggarwal Medical Centre, E-234, Part 1, Greater Kailash, New Delhi-110048, in the treatment administered to the complainant, was confirmed by the Delhi Medical Council.
- The Order of the Disciplinary Committee in complaint No. 2594 of Shri Pradeep (xiv) Kumar, s/o Shri Jagmohan Lal, r/o 1595, Pana Mamurpur, Narela, Delhi-110040 alleging medical negligence on the part of Dr. K.K. Jindal of Maharaja Agrasen Hospital, West Punjabi Bagh, New Delhi-110026, in the treatment of the complainant's wife, resulting in her death, was confirmed by the Delhi Medical Council.
- The Order of the Disciplinary Committee in complaint No. 3488- a representation (xv)from Dy. Commissioner of Police Dwarka District, New Delhi, seeking medical opinion on a complaint of Smt. Sunita Devi, alleging medical negligence on the part of the doctors of Mahavir Multispecialty Hospital, Block K-4/12A, Near Gagan Bharti School, Mohan Garden, Uttam Nagar, New Delhi-110059, in the treatment of complainant's daughter Smt. Kajal, resulting in her death on 03.11.2021 at BM Gupta Hospital, where she was subsequently treated, was taken up for confirmation before the Delhi Medical Council.

Whilst confirming the decision of the Disciplinary Committee, the Council observed that in facts and circumstances of this case, the punishment of removal of name of Dr. Angad Singh for a period of 30 days from the State Medical Register of the Delhi Medical Council, will not serve the interest of justice; hence, the Council directs that punishment awarded to Dr. Angad Singh be enhanced and the name of Dr. Angad Singh (Delhi Medical Council Registration No. 7527) is removed for a period of 180 days from the State Medical Register of the Delhi Medical Council.

The Council further observed that the Order directing the removal of name from the State Medical Register of Delhi Medical Council shall come into effect after 60 days from the date of the Order.

This observation is to be incorporated in the final Order to be issued. The Order of the Disciplinary Committee stands modified to this extent and the modified Order is confirmed.

The Council further observed that the Order directing the issuance of warning shall come into effect after 60 days from the date of the Order.

This observation is to be incorporated in the final Order to be issued. The Order of the Disciplinary Committee stands modified to this extent and the modified Order is confirmed.

- 1. The Finance Committee approved the Annual Accounts and Auditors report of the Council for the F.Y. 2021-2022.
- 2. The Finance Committee approved the Auditors Bill amounting to Rs.66,000/- + G.S.T. for Annual Audit of the Council for the F.Y. 2021-2022.
- 3. The Finance Committee approved the Renewal of Health Insurance Policy from National Insurance Company Limited for the Permanent Employees of the Council.
- 4. The F.D.R. with PNB Housing Finance Limited amounting to Rs.5,00,00,000/- which is maturing on 04/10/2022 with Maturity value amounting to Rs.5,29,93,496/- was presented before the Finance Committee of the Council. The Finance Committee decided that a single FDR amounting to Rs.5,00,00,000/- may be made with PNB Housing Finance Limited for a period of 5 years @ 7.30% per annum(Tentative yield on Maturity is 8.45%) and Interest the Council with Canara Bank, MAMC branch.

The Finance Committee also decided that this Health Insurance Policy from National Insurance Company Limited will also be continued in future on completion of the Council Membership term of five years in case of Members of the Council and after retirement from the Council's service in case of Permanent Employees of the Council.
