The meeting was adjourned at 2.30 pm due to lack of quorum. The meeting was reconvened at 3.00 pm.

1. Minutes of the meeting held on 30th September, 2019.

The minutes of the Council meeting held on 30th September, 2019 were circulated to all the members present, for information.

2. Action taken report of minutes of the meeting held on 30th September, 2019.

Action taken reports, which were circulated to all the members present, were approved. The same are appended herewith as **Annexure 'A'** (colly).

3. To discuss cases of medical negligence and unethical conduct.

- (a) The Order of the Executive Committee in complaint No.2802 of Shri Sanjeev Mishra, r/o- B-64/H-1B, Shalimar Garden Extension-2, Sahibabad, Ghaziabad, Uttar Pradesh, alleging medical negligence on the part of Dr. Gunjan Kacker, Aveya IVF & Fertility Centre, E-8, Vishal Enclave, Rajouri Garden, Delhi-110027, in the treatment administered to complainant's wife Smt. Savita Mishra, was confirmed by the Delhi Medical Council.
- (b) The Order of the Executive Committee in complaint No.2872-a representation from Police Station, South Rohini, Dehli, seeking medical opinion regarding alleged medical negligence and professional misconduct, in the treatment administered to Shri. Rajesh Bahadur Singh, A-1/97C, DDA Flats, Paschim Vihar, Delhi at Jaipur Golden Hospital, Sector-03, Rohini, Delhi-110085, was confirmed by the Delhi Medical Council.
- (c) The Order of the Executive Committee in complaint No.2814 of Shri Prashant Bhardwaj, G-202, Rajasthan Apartments, Plot No. 36, Sector-4, Dwarka, New Delhi-110078, alleging medical negligence on the part of Dr. Ramji Mehrotra of Fortis Escorts Hospital, New Friends Colony, New Delhi, in the treatment of complainant's father Shri Ramesh Chander Bhardwaj, resulting in his death, was confirmed by the Delhi Medical Council.
- (d) The Order of the Executive Committee in complaint No.2740-a representation from Dy. Commissioner of Police, West Distt., Delhi, seeking medical opinion on a complaint of Shri Manoj Shah, r/o- G-2/41, Sai Enclave Mohan Garden,

Uttam Nagar, Delhi, forwarded by the Medical Council of India, alleging medical negligence on the part of Deen Dayal Upadhyay Hospital Hari Nagar, New Delhi-110064, in the treatment administered to complainant's son Master Mohit, resulting in his death on 11.11.2017 at Deen Dayal Upadhyay Hospital, was confirmed by the Delhi Medical Council.

- (e) The Order of the Disciplinary Committee in complaint No.2568 of Shri S.S. Rana, for Chairman/RRC, Northern Railway, Office of the Chairman, Railway Recruitment Cell (RRC), Lajpat Nagar-I, New Delhi-110024, seeking verification of genuineness of a medical certificate issued by Dr. S.K. Singh, 4A, Main Road, Khanpur, New Delhi-110062 to one Sh. Om Prakash, was confirmed by the Delhi Medical Council.

The Council also confirmed the punishment of removal of name of Dr. S.K. Singh (Dr. Suresh Kumar Singh, Delhi Medical Council Registration No.9399) for a period of 60 days awarded by the Disciplinary Committee.

The Council further observed that the Order directing the removal of name from the State Medical Register of Delhi Medical Council shall come into effect after 30 days from the date of the Order.

This observation is to be incorporated in the final Order to be issued. The Order of the Disciplinary Committee stands modified to this extent and the modified Order is confirmed.

- (f) The Order of the Disciplinary Committee in complaint No.2154 of Shri Anil Mahajan, alleging medical negligence on the part of doctors of Fortis Hospital, Vasant Kunj in the treatment of complainant's daughter-in-law Smt. Suchita Rajat Mahajan, resulting in death of her new born baby on 10.07.2017, was confirmed by the Delhi Medical Council.

The Council also confirmed the punishment of removal of name of Dr. Rachna Varma (Delhi Medical Council Registration No.8409) and Dr. Rekha (Delhi Medical Council Registration No.28849) for a period of 30 days awarded by the Disciplinary Committee with a direction that Dr. Rekha should undergo twelve hours of Continuing Medical Education(C.M.E.) on the subject 'Labour

Management' within a period of six months and submit a compliance report to this effect to the Delhi Medical Council.

The Council further observed that the Order directing the removal of name from the State Medical Register of Delhi Medical Council shall come into effect after 30 days from the date of the Order.

This observation is to be incorporated in the final Order to be issued. The Order of the Disciplinary Committee stands modified to this extent and the modified Order is confirmed.

- (g) The Order of the Disciplinary Committee in complaint No.2231 of Shri Pramod Singh s/o Mr. L.B. Singh, r/o- House No.12, Main Road, Indraprastha Colony Part-1, Burari, Delhi-110084, alleging medical negligence on the part of Dr. Sona Bathla, Dr. Preeti Yadav and Dr. Sweta Balani of Sant Parmanand Hospital, 18, Sham Nath Marg, Civil Lines, Delhi, in the treatment administered to the complainant's wife Smt. Shruti Singh, resulting in her death on 25.03.2017 at Sant Parmanand Hospital, was confirmed by the Delhi Medical Council.
- (h) The Order of the Disciplinary Committee in complaint No.2066-a representation from police station, Saket, seeking medical opinion regarding alleged medical negligence in the treatment of Shri Rahul Talwar r/o D-1407, Amrapali Zodiac, Sector-120, Noida (UP)-201301 at Max Hospital, Saket, New Delhi, was confirmed by the Delhi Medical Council.
- (i) The Order of the Disciplinary Committee in complaint No.2348 of Shri Devender Singh s/o Shri Omvir Singh r/o A-37, Amrit Puri, Garhi, East of Kailash, New Delhi-110065, forwarded by the Medical Council of India, alleging medical negligence on the part of Dr. Arvind Soni, in the treatment of complainant at Indraprastha Apollo Hospital, Sarita Vihar, New Delhi-110076, was confirmed by the Delhi Medical Council.

4. To discuss about the Minutes of the Anti Quackery Committee.

The minutes of the meeting of the Anti-Quackery Committee of the Delhi Medical Council held on 17th October, 2019 (appended herewith as annexure 'B') which were circulated to the members present, were confirmed.

5. To discuss about the Minutes of CME Committee.

The Secretary informed that there are no minutes of the CME Committee of the Delhi Medical Council on which discussion is required, as no meeting of the CME Committee of the Delhi Medical Council had been convened.

6. To discuss about the Minutes of the Finance Committee.

The minutes of the meeting of the Finance Committee of the Delhi Medical Council held on 14th November, 2019 (**appended herewith as annexure 'C'**) which were circulated to the members present, were confirmed.

7. To discuss the development in space allotment at DMRC IT Park, Shastri Park, Metro Station.

The president of the Council briefed the General Body of the Council about the letter sent to Delhi Government for Assisting in tendering process and be a part of the tendering process of the office renovation work at Delhi Metro Railway Corporation, IT Park, Shastri Park, Metro Station, Delhi-110053.

The General Body of the Council decided that the cost of the project be kept at as low as possible keeping in mind the restriction imposed by Delhi Metro Railway Corporation with the nominated member/department from Delhi Government guiding the architect in the Council work at DMRC IT Park, Shastri Park, Metro Station, Advertisement received from the Architect firm M/s Sandeep Geeta & Associates may be published in the newspapers for inviting tenders for renovation of office space at DMRC, Park, Shastri Park, Metro Station, Delhi-110053, after getting vetted from nominated member/department.

8. Any other item with permission of Chair.

- (a) The minutes of the meeting of the Land & Building Committee of the Delhi Medical Council held on 17th October, 2019 (**appended herewith as annexure 'D'**) which were circulated to the members present, were confirmed.
- (b) The issue regarding the expiry of term of the present Council was taken up for discussion.

The Registrar briefed that regarding the expiry of term of the present Council, a letter was sent to the Govt. of NCT of Delhi wherein it was submitted that the present Council was constituted vide Gazette Notification No.F.32/13/2009/H&FW/1985-91 dated 13th March, 2015 and the term of office of the members was to be five years from the date of publication of that notification. Subsequently, another notifications No.F.32/39/2009/H&FW/DMC/2012/CD#112181872/js3hw/630-636 dated 28th September, 2015 and Notification No.F.32/39/2009/H&FW/DMC/2012/js3hfw/920-927 dated 24th November, were issued. The Govt. of NCT of Delhi was asked to clarify as to when does the term of the present Council expires. In reply, the Deputy Secretary (Council), Government of National Capital territory of Delhi, Health & Family Welfare Department, vide his letter F.No.F.98/H&FW/2019/Council/1371 dated 13th November, 2019 has informed that *"it is clearly mentioned in notification dated 28.09.2015 and 24.11.2015 that subject to provisions of the aforesaid Act, the term of the above matter shall be for the remaining period from the date of publication of this Notification"*.

The members of the Council were of the view that since the present Council's first meeting, after constitution as per Notification No.F.32/13/2009/H&FW/1985-91 dated 13th March, 2015, was called only on 8th December, 2015, and till that time, the previous Council was discharging the functions; hence, the term of the present Council should deem to commence from 8th December, 2015, consequently, the term should expire on 8th December, 2020.

This view of the Council's members be brought to the notice of the Govt. of NCT of Delhi and in light of the same, again, a clarification be sought regarding the expiry of term of the present Council from the Govt. of NCT of Delhi.

The Registrar stated that if, no clarification is received, the Registrar being the Returning Officer shall initiate the process for reconstitution of the Council in accordance in the provisions of the Delhi Medical Council Act and Rules made thereunder.

- (C) The Council noted that vide order No.DMC/DC/F.14/Comp.2011/2/2017/265499 to 265507 dated 11th September, 2017 in complaint No. 2011, besides imposing

penalty of suspension of 365 days on Dr. Vikas Patel, the Delhi Medical Council has also indicted Dr. Govind Anoop Raj for act of professional misconduct. However since at the time of passing of the aforementioned order Dr. Govind Anoop Raj did not hold valid registration with Delhi Medical Council, as his name already stood deleted w.e.f. 19th May, 2017 under Delhi Medical Council registration No.15302, on account of non renewal, no punishment in terms of warning or suspension of registration was inflicted on Dr. Govind Anoop Raj and in terms of the said order criminal prosecution was initiated against Dr. Govind Anoop Raj u/s 15(3) of Indian Medical Council Act, 1956, as he was found to have been practising without having valid registration with Delhi Medical Council.

It is noted that subsequently, Dr. Govind Anoop Raj had renewed his registration with Delhi Medical Council. In view of the fact that Dr. Govind Anoop Raj had renewed his registration with Delhi Medical Council, the Council is of the view that criminal prosecution against him, may be withdrawn. However, since, the Delhi Medical Council in its order dated 19th May, 2017 has indicted Dr. Govind Anoop Raj for professional misconduct, he may be issued a notice to appear before the Disciplinary Committee and to show cause as to why penalty which includes warning or suspension of registration be not imposed on him for his act of professional misconduct, as reflected in the aforementioned Delhi Medical Council order.

A meeting of the Anti Quackery Committee of the Delhi Medical Council was held on 17th October, 2019 at 3:00 p.m. in the office of Delhi Medical Council

1. **Shri P.K Gupta:** - Shri P.K Gupta neither replied nor appeared before the Anti-Quackery Committee in response to Show Cause Notice No.DMC/AQ/F.3-A/SCNs/2/2019/285576 dated 07th October, 2019. The Anti Quackery Committee noted that notice sent to Shri P.K Gupta returned undelivered in the office of Delhi Medical Council with noting from the Postal Department "Incomplete Address".

In the light of the above the Anti-Quackery Committee directed that the concerned Chief District Medical Officer (North East District) be asked to provide complete and correct address of Shri P. K Gupta to the office of the Delhi Medical Council. Once the same is received, show cause notice again be issued to Shri P.K Gupta.

2. **Shri Nazim:-** Shri Nazim neither replied nor appeared before the Anti-Quackery Committee in response to Show Cause Notice No.DMC/AQ/F.3-A/SCNs/2/2019/285577 dated 07th October, 2019. On examination of the inspection report no. No.F.No.11/2013/AQ/XVIII/4/NED/1322 dated 21st August, 2018 received from the office of the CDMO (North East District), in respect of Shri Nazim the Anti Quackery Committee noted that Shri Nazim has been practicing allopathy without holding any requisite medical qualification as enumerated in the Schedules I, II, III of the Indian Medical Council Act 1956, entitling him to practice in allopathy and also not being registered with the Delhi

Medical Council, in violation of the Section 15(6) of the Delhi Medical Council Act, 1997.

In light of the above, the Anti Quackery Committee, hereby, in exercise of powers conferred under section 10(h) of the Delhi Medical Council, Act, 1997 recommends that Shri Nazim be directed to stop practicing allopathy, forthwith, and to close down his clinic and Anti Quackery Committee also decided that the police be requested to register a FIR under Section 27 of Delhi Medical Council Act, 1997 alongwith relevant Section of IPC.

3. **Dr. Anupam Kaur:-** In response to show cause notice no. DMC/AQ/F.3/SCNs/2/2019/285578 dated 07th October, 2019 Dr. Anupam Kaur neither filed her statement of defense nor appeared before the anti quackery Committee but her father Dr. Jaswant Singh appeared on her behalf in Anti Quackery Committee and stated that Dr. Anupam Kaur presently is servicing in the state government of Punjab.

On examination of the inspection report no. F.No.1(19)/7/2014/A.Q.insp/DHS/CDMO/CENTRAL/1384 dated 08th August 2019 received from the office of the CDMO(Central District), The Anti Quackery Committee noted that at the time of inspection, Dr.Anupam Kaur was not present at the said clinic, but her father Dr. Jaswant Singh was present and he has been practicing ayurvedic system of medicine.

The Committee further noted that Dr. Anupam Kaur was registered with Delhi Medical Council under registration number. 57766 dated 29th June, 2012 with qualification of M.B.B.S, Tianjin Medical University, China, 2011, as her registration has been expired on 28th June, 2017 on account of non renewal of registration. The Anti Quackery Committee further observed Dr. Jaswant Singh is registered with the Delhi Bharatiya Chikitsa Parishad under registration No.B A/5643 dated 02nd January 2018.

In view of the above, the Anti-Quackery Committee observed that Dr. Anupam Kaur possess the requisite medical qualification as the Schedules to the Indian Medical Council Act, 1956 her registration with DMC has expired because on account of non renewal and she is practicing in Punjab and there is no finding of allopathic system of medicine against Dr. Jasmeet Singh, hence, no further action is warranted in this matter.

Matter stands closed.

4. **Shri. Kishore Kumar Babbar:-** Shri Kishore Kumar Babbar appeared before the Anti-Quackery Committee and submitted a reply. The reply submitted by Shri Kishore Kumar Babbar was found to be unsatisfactory in response to Show Cause Notice. DMC/AQ/F.3-A/SCNs/2/2019/ dated 07th October, 2019. Hence the matter referred to be Delhi Dental Council for appropriate action.
5. **Shri Ravi Kumar:-** Shri Ravi Kumar neither replied nor appeared before the Anti-Quackery Committee in response to Show Cause Notice No.DMC/AQ/F.3-A/SCNs/2/2019/285580 dated 07th October, 2019. The Anti Quackery Committee noted that notice sent to Shri Ravi Kumar returned undelivered in the office of Delhi Medical Council with noting from the Postal Department "No Such Person".

In the light of the above the Anti-Quackery Committee directed that the concerned Chief District Medical Officer (North West District) be asked to provide complete and correct address of Shri Ravi Kumar to the office of the Delhi Medical Council. Once the same is received, show cause notice again be issued to Shri Ravi Kumar.

6. **Shri Md. Qasim:-** Shri Md. Qasim appeared before the Anti-Quackery Committee and submitted a reply. The reply submitted by Shri Md. Qasim was found to be unsatisfactory in response to Show Cause Notice No.DMC/AQ/F.3-A/SCNs/2/2019/285581 dated 07th October, 2019. On examination of the inspection report no. F.1/17/(Part XXVIII)/2001/DHS/NWD/AQ/2350-52 dated 29th July 2019 received from the office of the CDMO(North West District), in respect of Shri Md. Qasim the Anti Quackery Committee noted that Md. Qasim has been practicing allopathy without holding any requisite medical qualification as enumerated in the Schedules I, II, III of the Indian Medical Council Act 1956, entitling him to practice in allopathy and also not being registered with the Delhi Medical Council, in violation of the Section 15(6) of the Delhi Medical Council Act, 1997.

In light of the above, the Anti Quackery Committee, hereby, in exercise of powers conferred under section 10(h) of the Delhi Medical Council, Act, 1997 recommends that Shri Md. Qasim be directed to stop practicing allopathy, forthwith, and to close down his clinic and Anti Quackery Committee also decided that the police be requested to register a FIR under Section 27 of Delhi Medical Council Act, 1997 alongwith relevant Section of IPC.

7. **Shri S. C Sharma:-** Shri S. C Sharma appeared before the Anti-Quackery Committee and submitted a reply. The reply submitted by Shri S. C Sharma was found to be unsatisfactory in response to Show Cause Notice No.DMC/AQ/F.3-A/SCNs/2/2019/285582 dated 07th October, 2019. On examination of the inspection report no. F.1/17/(Part XXVIII)/2001/DHS/NWD/AQ/2363-65 dated 29th July 2019 received from the office of the CDMO(North West District), in respect of Shri S.C Sharma the Anti Quackery Committee noted that S. C Sharma has been practicing allopathy without holding any requisite medical qualification as enumerated in the Schedules I, II, III of the Indian Medical Council Act 1956, entitling him to practice in allopathy and also not being registered with the Delhi Medical Council, in violation of the Section 15(6) of the Delhi Medical Council Act, 1997.

In light of the above, the Anti Quackery Committee, hereby, in exercise of powers conferred under section 10(h) of the Delhi Medical Council, Act, 1997 recommends that Shri S. C Sharma be directed to stop practicing allopathy, forthwith, and to close down his clinic and Anti Quackery Committee also decided that the police be requested to register a FIR under Section 27 of Delhi Medical Council Act, 1997 alongwith relevant Section of IPC.

8. **Shri Varun Sarkar: -** Shri Varun Sarkar neither replied nor appeared before the Anti-Quackery Committee in response to Show Cause Notice No.DMC/AQ/F.3-A/SCNs/2/2019/285583 dated 07th October, 2019. On examination of the inspection report no. No. File.No.F.20(1)/Antiquackery/DHS/WD/2003/2735-2738 dated 25th July 2019 received from the office of the CDMO (West District), in respect of Shri Varun Sarkar the Anti Quackery Committee noted that Shri Varun Sarkar has been practicing allopathy without holding any requisite medical qualification as enumerated in the Schedules I, II, III of the Indian Medical Council Act 1956, entitling him to practice in allopathy and also not being registered with the Delhi Medical Council, in violation of the Section 15(6) of the Delhi Medical Council Act, 1997.

In light of the above, the Anti Quackery Committee, hereby, in exercise of powers conferred under section 10(h) of the Delhi Medical Council, Act, 1997 recommends that Shri Varun Sarkar be directed to stop practicing allopathy, forthwith, and to close down his clinic and Anti Quackery Committee also decided that the police be requested to

register a FIR under Section 27 of Delhi Medical Council Act, 1997 alongwith relevant Section of IPC.

9. **Dr. Vinod Kumar Gupta:-** Dr. Vinod Kumar Gupta neither replied nor appeared before the Anti-Quackery Committee in response to show cause notice no.DMC/AQ/F.3-A/SCNs/2019/285583 dated 07th October, 2019.

In the interest of justice, the Anti Quackery Committee decided to grant one more opportunity to Dr. Vinod Kumar Gupta to present his defence in person before the Anti-Quackery Committee.

1. The Finance Committee of the Council approved the three months Accounts of the Council from 01/07/2019 to 30/09/2019. The Three months Accounts of the above-said period is attached herewith.



1. The Finance Committee, Land & Building Committee approved the Payment of Bill of M/s Sandeep Geeta & Associates Pvt. Ltd. Amounting to Rs.1,41,600/- (Rs.1,20,000/- plus GST 18%) for getting the N.O.C. from DMRC on 09/10/2019 after deducting TDS. As per the Consultancy Work order dated 29th May, 2019 a Penalty @ 2% per month of the total consultancy fee will be imposed for delay in approval from DMRC. However, the Members felt that the delay in obtaining the N.O.C. from DMRC was due to DMRC, so no deduction on the Consultancy fees is imposed on M/s Sandeep Geeta & Associates Pvt. Ltd.
 2. Letter received from M/s Sandeep Geeta & Associates Pvt. Ltd was placed before the Finance Committee, Land & Building Committee in which they have stated the approximate cost of the Project amounting to Rs.3.5 crores Plus GST in reference to the specifications proposed by DMRC & their modifications from time to time. The Finance, Land & Building Committee approved the approximate cost of the project amounting to Rs.3.5 crores plus GST and decided that after approval of the approximate cost by the Executive Committee, General Body of the Council a letter may be sent to Delhi Government for Assisting in Tendering Process and be a part of the Tendering Process for the above stated project of Office Interior work at DMRC IT Park, Shastri Park, Delhi-110053.

Tax Invoice received from DMRC in which DMRC have demanded a sum of Rs.18,22,110/- for advance rent, Maintenance charges, Water Charges from 01/11/2019 to 31/12/2019 was placed before the Finance, Land & Building Committee of the Council. Letter sent to Sh.M.C.Sharma, Sr.DGM/PD-II and Sh.S.D.Sharma, Director(Business Development) for waiving – off the above said amount of Rs.18,22,110/- (Copy attached) was also placed before the Finance, Land & Building Committee of the Council.
