**3. To discuss cases of medical negligence and unethical conduct.**



- (i) The Order of the Executive Committee in complaint 2302 of Shri Laxmi Narayan Singh, r/o-House No.11, Gali No.1, Laldora, Near Level Chowk, Sant Nagar, Burari, Delhi-110084, forwarded by the Directorate General of Health Services, alleging medical negligence and professional misconduct on the part of doctors of Rajiv Gandhi Cancer Hospital, Sector-05, Rohini, Delhi-110085, in the treatment administered to complainant wife Smt. Vedanti Devi Singh, was confirmed by the Delhi Medical Council.
- (ii) The Order of the Executive Committee in complaint No.2437 of Ms. Kanika Gulati, r/o- BH-403, F.F., Shalimar Bagh(East), Delhi-110088, forwarded by the Health and Family Welfare Department, Govt. of NCT of Delhi, alleging medical negligence in the treatment administered to complainant's father Shri. Mahinder Kumar Rajpal at Sushruta Trauma Center, Civil Lines, Govt. of NCT of Delhi and Fortis Hospital, resulting in his death on 16.10.2017, was confirmed by the Delhi Medical Council.

Dr. Arun Kumar Gupta recused himself from the proceedings.

- (iv) The Order of the Executive Committee in complaint No.2300-a representation from Police Station, Shalimar Bagh, New Delhi, seeking medical opinion on a complaint of Sh. Mohd. Isrile s/o Shri. Mohd. Yasin r/o- House No.544, Pocket-II, Sector-A-6, Narela, Delhi alleging medical negligence in the treatment administered to complainant daughter Ms. Nazma at Max Super Specialty Hospital, Shalimar Bagh, FC-50, C & D Block, Shalimar Bagh, New Delhi-110088, was confirmed by the Delhi Medical Council.

- (vi) The Order of the Executive Committee in complaint No.2566 of Smt. Darshana Choudhary, r/o B-24, First Floor, Karpura, New Delhi-110015, alleging medical negligence on the part of the doctors of AcharyaShree Bhikshu Government Hospital, Moti Nagar, Delhi-110015, in the treatment of complainant, was confirmed by the Delhi Medical Council.
- (vii) The Order of the Executive Committee in complaint No.2378 of Shri Ram Pyare Yadav s/o Late Shri Chhedi Ram, r/o 188-S, Chhatra Sangh Chaurha, Bliundpur, Gorakhpur (UP)-273001 alleging medical negligence on the part of doctors of Max Hospital Saket, Delhi in the treatment of complainant's daughter Ms. Harshita Yadav, resulting in her death, was confirmed by the Delhi Medical Council.
- (viii) The Order of the Executive Committee in complaint No.2536 of Shri Uttam Chand Meena, r/o- 17-D, Vikas Niketan North Extn., Pitam Pura, Near Agrasen Dharamshala, Delhi-110034 against doctors of Saroj Super Specialty Hospital, was taken up for confirmation before the Delhi Medical Council.

Dr. Ajay Gambhir recused himself from the proceedings.

- (ix) The Order of the Executive Committee in complaint No.2565 of Shri Dinesh Chopra s/o Shri S.C. Chopra, r/o P3 C33, Princeton Estate, DLF Phase V, Gurgaon, Haryana, forwarded by the Medical Council of India alleging medical negligence in the treatment of complainant's mother Smt. Pushpa



Chopra at Pentamed Hospital, 7 Local Shopping Centre, Derawal Nagar, Gujranwala Town, Phase IV, Delhi-110009 and BL Kapoor Hospital, Pusa Road, Rajinder Nagar, Delhi, resulting in her death on 19.01.2018, was confirmed by the Delhi Medical Council.

- (x) The Order of the Disciplinary in complaint No.2406- A representation from Police Station, Samepur, Badli, New Delhi, seeking medical opinion on a complaint of Shri Guddu Kamti, r/o- J-517, Gali no.14, Swaroop Nagar, Budh Bazar Road, Pehelwan Chowk, Delhi, alleging medical negligence on the part of doctors of City Hospital, Main Bazar, Samepur, Delhi-110042, in the treatment administered to complainant's wife Smt. Rakhi, resulting in her death on 22.02.2018, was confirmed by the Delhi Medical Council.

The Council also confirmed the punishment of removal of name awarded to Dr. Sanjana Jain (Delhi Medical Council Registration No.11960) by the Disciplinary Committee with a direction that she should undergo twelve hours of Continuing Medical Education (C.M.E.) on the subject "Labour Management" within a period of three months and submit a compliance report to this effect to the Delhi Medical Council.

The Council further observed that the Order directing the removal of name from the State Medical Register of Delhi Medical Council shall come into effect after 30 days from the date of the Order.

This observation is to be incorporated in the final Order to be issued. The Order of the Disciplinary Committee stands modified to this extent and the modified Order is confirmed.

- (xi) The Order of the Disciplinary Committee in complaint No.2436- a representation from Police Station Shahdara, Delhi, seeking medical opinion on a complaint of Shri Raj Kishore Goyal s/o Shri Nanak Chand Goyal, r/o- 406, Krishna Gali no.10, Adarsh Mohalla Maujpur, Delhi-110053, alleging medical negligence on the part of Dr. Sunita Gupta and Dr. M.K Gupta of Shivani Maternity & Ultrasound Centre, 1/9642, Bahl Street Hanuman Road,

West Rohtash Nagar, Shahdara, Delhi-110032, in the treatment administered to complainant's wife Smt. Chanchal Goyal, was taken up for confirmation before the Delhi Medical Council.

Whilst confirming the Order of the Disciplinary Committee, the Council observed that in this case the post-operative shock was treated as per protocol by attending doctors and the patient was timely referred to the higher centre for further management.

The Council further observed that the records were handed over to the police within 72 hours.

In view of the above, the Council directed that the punishment awarded by the Disciplinary Committee to Dr. Sunita Gupta and Dr. Mukesh Gupta, Medical Superintendent, Shivani Maternity & Ultrasound Centre is not warranted, hence, no warning is required. The Council further directed that direction given by the Disciplinary Committee to Dr. Sunita Gupta to undergo 8 hours of Continuing Medical Education (C.M.E.) on the subject "Management of LSCS related complications" is also not warranted.

This observation is to be incorporated in the final Order to be issued. The Order of the Disciplinary Committee stands modified to this extent and the modified Order is confirmed.

- (xii) The Order of the Disciplinary Committee in complaint No.2456 of Shri B.K.K. Sinha, Plot No. 270, F-1, Sector-4, Vaishali-201010, Distt. Ghaziabad, alleging medical negligence on the part of Dr. Divya Aggarwal, in the treatment of complainant's wife Smt. Priti Ranjan at Shanti Gopal Hospital, NH-1, Ahinsa Khand -II, Indirapuram, Ghaziabad, was confirmed by the Delhi Medical Council.

Pant Hospital, New Delhi-110002, resulting in her death on 7.2.2014 was confirmed by the Delhi Medical Council.

Dr. Satendra Singh recused himself from the proceedings.

The Council also confirmed the punishment of warning awarded to Dr. Rahul Anshuman (Delhi Medical Council Registration No.DMC/R/7033) with a direction that he should undergo 2 weeks C.M.E. (Continuing Medical Education) on the subject 'Hip Injury' within a period of three months and to submit a compliance report to this effect to the Delhi Medical Council.

This observation is to be incorporated in the final Order to be issued. The Order of the Disciplinary Committee stands modified to this extent and the modified Order is confirmed.

- (xviii) The Order of the Disciplinary Committee in complaint No.2391 of Shri Sharad Chandan, Administrative Officer, Central Estt. Department, East Delhi Municipal Corporation, Central Establishment Department, Udyog Sadan, 419, Patparganj, Industrial Area, Delhi-110092, seeking verification of genuineness of a medical certificate dated 13<sup>th</sup> December, 2017 (15-11-2017 to 13-12-2017), issued by Dr. Ashutosh Kumar, Raj Clinic, 12/1, Indra Vikas Colony, Delhi-110009 to one Shri Rajeev Malik, was taken up for confirmation before the Delhi Medical Council.

Whilst confirming the Order of the Disciplinary Committee, the Council directed that this matter be also reported to the concerned Chief District Medical Officer with a request to carry out an inspection/survey at the aforesaid clinic.

This observation is to be incorporated in the final Order to be issued. The Order of the Disciplinary Committee stands modified to this extent and the modified Order is confirmed.

- (xix) The Order of the Disciplinary Committee in complaint No.1500 of Shri Sandeep Sharma, forwarded by the Medical Council of India, alleging medical negligence on the part of Dr. Arima Nigam, Dr. Anshu Kumar Aggarwal and G.B. Pant Hospital, in the treatment administered to the complainant's mother Smt. Sneha Sharma at G.B. Pant Hospital, resulting in her death on 21.12.2014, was confirmed by the Delhi Medical Council.
- (xx) The Order of the Disciplinary Committee in complaint No.1911 of Shri Jai Prakash s/o Shri Ram Mehar r/o- House No.48A, Village Safiyabad, P.O. Nathu Pur, Distt. Sonapat (HR), Pin-131029, alleging medical negligence on the part of doctors of Satyawadi Raja Harish Chandra Hospital, Narela, Delhi-110040, in the treatment administered to complainant's baby Latika resulting in her death, was confirmed by the Delhi Medical Council.

The Council also confirmed the punishment of warning awarded to Dr. Vivek Kumar (Delhi Medical Council Registration No.12749), Dr. Amol Ramkrushna Kholapure (Delhi Medical Council Registration No.DMC/R/07691) and Dr. Ashwin Patidar (Dr. Ashwini Patidar, Delhi Medical Council Registration No.57124) with a direction that they should undergo twelve hours of Continuing Medical Education (C.M.E.) on the subject 'Paediatric Emergency and Management of Anaemia in Children' within a period of three months and to submit a compliance report to this effect to the Delhi Medical Council.

This observation is to be incorporated in the final Order to be issued. The Order of the Disciplinary Committee stands modified to this extent and the modified Order is confirmed.

1. **Shri Chandrakant Bakshi:-** Shri Chandrakant Bakshi appeared before the Anti-Quackery Committee and submit a written statement in response to Show Cause Notice No. DMC/AQ/F.3-A/SCNs/2/2018/276979 dated 1<sup>st</sup> November, 2018. On examination of the inspection report no. F.No.1(19)/(7)/2014/A.Q.insp./DHS/CDMO/Central/3003 dated 27<sup>th</sup> September, 2018 of the Chief District Medical Officer (Central District), in respect of Shri Chandrakant Bakshi, the Anti Quackery Committee noted that Shri Chandrakant Bakshi, has been practicing allopathy without holding any requisite medical qualification as enumerated in the Schedules I, II, III of the Indian Medical Council Act 1956, entitling him to practice in allopathy and also not being registered with the Delhi Medical Council, in violation of the Section 15(6) of the Delhi Medical Council Act, 1997.

In light of the above, the Anti Quackery Committee, hereby, in exercise of powers conferred under section 10(h) of the Delhi Medical Council, Act, 1997 recommends that Shri Chandrakant Bakshi be directed to stop practicing allopathy, forthwith, and to close down his Clinic and Anti Quackery Committee also decided that the police be requested to register a FIR under Section 27 of Delhi Medical Council Act, 1997 alongwith relevant Section of IPC.

2. **Shri Budho Biswas:-** Shri Budho Biswas neither replied nor appeared before the Anti-Quackery Committee in response to Show Cause Notice No. DMC/AQ/F.3-A/SCNs/2/2018/276982 dated 1<sup>st</sup> November, 2018. The Anti-Quackery Committee noted that notice sent to Shri Budho Biswas returned undelivered in the office of Delhi Medical Council with noting from the Postal Department "Incomplete Address".

In light of the above, the Anti-Quackery Committee directed that the concerned CDMO (East District) be asked to provide complete and correct address of Shri Budho Biswas to the office of Delhi Medical Council. Once the same is received, show cause notice again be issued to Shri Budho Biswas.

3. **Shri Manojit Kumar Ray:-** Shri Manojit Kumar Ray appeared before the Anti-Quackery Committee and submit a reply alongwith a copy of his BAMS degree awarded by Rajiv Gandhi University of Health Sciences, Bengaluru University, but he has not completed his internship and not registered with Delhi Bharatiya Chikitsa Parishad. The reply submitted by Shri Manojit Kumar Ray was found to be unsatisfactory in response to Show Cause Notice No. DMC/AQ/F.3-A/SCNs/2/2018/276987 dated 1<sup>st</sup> November, 2018. On examination of the inspection report no. F.No.3/11/2015/AQIII/SHD/1670 dated 31<sup>st</sup> August, 2018 of the Chief District Medical Officer (Shahdara District), in respect of Shri Manojit Kumar Ray, the Anti Quackery Committee noted that Shri Manojit Kumar Ray, has been practicing allopathy without holding any requisite medical qualification as enumerated in the Schedules I, II, III of the Indian Medical Council Act 1956, entitling him to practice in allopathy and also not being registered with the Delhi Medical Council, in violation of the Section 15(6) of the Delhi Medical Council Act, 1997.

In light of the above, the Anti Quackery Committee, hereby, in exercise of powers conferred under section 10(h) of the Delhi Medical Council, Act, 1997 recommends that Shri Manojit Kumar Ray be directed to stop practicing allopathy, forthwith, and to close down his Clinic and Anti Quackery Committee also decided that the matter referred to Delhi Bhartiya Chikitsa Parishad for appropriate action.

4. **Shri Raman Kumar Biswas:-** Shri Raman Kumar Biswas appeared before the Anti-Quackery Committee and submitted a reply. The reply submitted by Shri Raman Kumar Biswas was found to be unsatisfactory in response to Show Cause Notice No. DMC/AQ/F.3-A/SCNs/2/2018/276989 dated 1<sup>st</sup> November, 2018. On examination of the inspection report no. F.No.3/11/2015/AQIII/SHD/1670 dated 31<sup>st</sup> August, 2018 of the Chief District Medical Officer (Shahdara District), in respect of Shri Raman Kumar Biswas, the Anti Quackery Committee noted that Shri Raman Kumar Biswas, has been practicing allopathy without holding any requisite medical qualification as enumerated in the Schedules I, II, III of the Indian Medical Council Act 1956, entitling him to practice in allopathy and also not being registered with the Delhi Medical Council, in violation of the Section 15(6) of the Delhi Medical Council Act, 1997.



In light of the above, the Anti Quackery Committee, hereby, in exercise of powers conferred under section 10(h) of the Delhi Medical Council, Act, 1997 recommends that Shri Raman Kumar Biswas, be directed to stop practicing allopathy, forthwith, and to close down his Clinic and Anti Quackery Committee also decided that the police be requested to register a FIR under Section 27 of Delhi Medical Council Act, 1997 alongwith relevant Section of IPC.

5. **Shri Alok:-** Shri Alok neither replied nor appeared before the Anti-Quackery Committee in response to Show Cause Notice No. DMC/AQ/F.3-A/SCNs/2/2018/276990 dated 1<sup>st</sup> November, 2018. The Anti-Quackery Committee noted that notice sent to Shri Alok returned undelivered in the office of Delhi Medical Council with noting from the Postal Department "Incomplete Address".

In light of the above, the Anti-Quackery Committee directed that the concerned CDMO (North East District) be asked to provide complete and correct address of Shri Alok to the office of Delhi Medical Council. Once the same is received, show cause notice again be issued to Shri Alok.

6. **Shri Naeem Tyagi:-** Shri Naeem Tyagi appeared before the Anti-Quackery Committee and submitted a reply. The reply submitted by Shri Naeem Tyagi was found to be unsatisfactory in response to Show Cause Notice No. DMC/AQ/F.3-A/SCNs/2/2018/276993 dated 1<sup>st</sup> November, 2018. On examination of the inspection report no. F.No.11/2013/AQ/XVIII/4/NED/1705 dated 23<sup>rd</sup> October, 2018 was received from the office of the CDMO (North East District), in respect of Shri Naeem Tyagi, the Anti Quackery Committee noted that Shri Naeem Tyagi, has been practicing allopathy without holding any requisite medical qualification as enumerated in the Schedules I, II, III of the Indian Medical Council Act 1956, entitling him to practice in allopathy and also not being registered with the Delhi Medical Council, in violation of the Section 15(6) of the Delhi Medical Council Act, 1997.

In light of the above, the Anti Quackery Committee, hereby, in exercise of powers conferred under section 10(h) of the Delhi Medical Council, Act, 1997 recommends that Shri Naeem Tyagi, be directed to stop practicing allopathy, forthwith, and to close down his Clinic and Anti Quackery Committee also decided that the police be requested to register a FIR under Section 27 of Delhi Medical Council Act, 1997 alongwith relevant Section of IPC.



7. **Shri Mohsin Khan:-** Shri Mohsin Khan appeared before the Anti-Quackery Committee and submitted a reply. The reply submitted by Shri Mohsin Khan was found to be unsatisfactory in response to Show Cause Notice No. DMC/AQ/F.3-A/SCNs/2/2018/276995 dated 1<sup>st</sup> November 2018. On examination of the inspection report no. F.No.11/2013/AQ/XVIII/4/NED/1705 dated 23<sup>rd</sup> October 2018 was received from the office of the CDMO (North East District) in respect of Shri Mohsin Khan, the Anti Quackery Committee noted that Shri Mohsin Khan has been practicing allopathy without holding any requisite medical qualification as enumerated in the Schedules I, II, III of the Indian Medical Council Act 1956, entitling him to practice in allopathy and also not being registered with the Delhi Medical Council, in violation of the Section 15(6) of the Delhi Medical Council Act, 1997.

In light of the above, the Anti Quackery Committee, decided that the police be requested to register a FIR under Section 27 of Delhi Medical Council Act, 1997 alongwith relevant Section of IPC.

8. **Dr. Mohammad Arif:-** Dr. Mohamamd Arif appeared before the Anti-Quackery Committee and filed a written statement wherein he stated that he has no association with Shri Mohsin Khan, Madina Hospital H.No.2042, Gali No.21-22, Main 25 Foota Road, Nearby Kabristan, Old Mustafabad, Delhi-110094. The written Statement by Dr. Mohamamd Arif was found satisfactory in response to Show Cause Notice No. DMC/AQ/F.3-A/SCNs/2/2018/276997 dated 1<sup>st</sup> November 2018, hence, no action is warranted by Delhi Medical Council against Dr. Mohamamd Arif.
9. **Shri Naushad Ali:-** Shri Naushad Ali appeared before the Anti-Quackery Committee and submitted a reply. The reply submitted by Shri Naushad Ali was found to be unsatisfactory in response to Show Cause Notice No. DMC/AQ/F.3-A/SCNs/2/2018/276998 dated 1<sup>st</sup> November 2018. On examination of the inspection report no. F.No.11/2013/AQ/XVIII/ 4/NED/1525 dated 14<sup>th</sup> September 2018 was received from the office of the CDMO (North East District), in respect of Shri Naushad Ali, the Anti Quackery Committee noted that Shri Naushad Ali, has been practicing allopathy without holding any requisite medical qualification as enumerated in the Schedules I, II, III of the Indian Medical Council Act 1956, entitling him to practice in allopathy and also not being registered with the Delhi Medical Council, in violation of the Section 15(6) of the Delhi Medical Council Act, 1997.


In light of the above, the Anti Quackery Committee hereby, in exercise of powers conferred under section 10(h) of the Delhi Medical Council Act, 1997 recommends that Shri Naushad Ali, be directed to stop practicing allopathy, forthwith, and to close down his Clinic and Anti Quackery Committee also decided that the police be requested to register a FIR under Section 27 of Delhi Medical Council Act, 1997 alongwith relevant Section of IPC.
