**3. To discuss cases of medical negligence and unethical conduct.**

- (i) The Order of the Executive Committee in complaint No.2504 of Sh. Pritam Singh r/o- S-806, Amrapalli Silicon City, Sector-76, Noida, U.P., forwarded by Medical Council of India, alleging medical negligence on the part of doctor of Centre for Sight in the treatment administered to the complainant, was confirmed by the Delhi Medical Council.
- (ii) The Order of the Executive Committee in complaint No.2561 of Shri Binod Kumar Gupta, C/o M/s Tirupati, Opp. Post Office, RKB Path, Dibrugarh, Assam-786001, forwarded by Medical Council of India, alleging professional misconduct on the part of doctors of Indraprastha Apollo Hospital in the



treatment of the complainant's son Shri Prakash Gupta, was confirmed by the Delhi Medical Council.

- (iii) The Order of the Executive Committee in complaint No.2087-a representation from the Police Station, I.P. Estate, Delhi, seeking medical opinion in respect of death of Late Dheeraj, s/o Ram Avadh, allegedly due to medical negligence on the part of doctors of Lok Nayak Hospital, was confirmed by the Delhi Medical Council.

Dr. Deepak K. Tempe recused himself from the proceedings.

- (vi) The Order of the Executive Committee in complaint No.2557 of Shri Nafees Ahmad r/o 4166, Lane No. 18/2, Shanti Mohalla, Gandhi Nagar, Delhi-110031, alleging medical negligence in the treatment administered to complainant's daughter baby Ms. Ekra Noor at Jain Charitable Hospital and Chacha Nehru Hospital, resulting in her death on 10.08.2018 at Max Hospital, Patparganj, where she was subsequently treated, was confirmed by the Delhi Medical Council.

negligence in the treatment administered to complainant's sister Smt. Manju Malhotra at Rajiv Gandhi Institute, resulting in her death on 14.05.2018, was confirmed by the Delhi Medical Council.

Avnish Singh, resulting in his death on 31.12.2017, was confirmed by the Delhi Medical Council.
- (xiv) The Order of the Executive Committee in complaint No. 2547 of Smt. Gagandeep Kaur , w/o Shri. S. Arvinder Singh, r/o-House No.570, Parmanand Colony, Delhi-110009, alleging medical negligence on the part of Dr. Asha Hans and Hans Hospital, GTB Nagar, Delhi, in the treatment administered to complainant, was confirmed by the Delhi Medical Council.
- (xv) The Order of the Executive Committee in complaint No.2661 of Ms. Pinki Rani, w/o Shri. Devender Kumar, r/o- 1226, Ram Lal Panna Village, Dichaon Kalan, South West, Delhi-110043, alleging medical negligence in examination/ preparation of PET Scan of complainant by doctors of Ganesh Diagnostic & Imaging Centre Private Limited, CS/OCF-7, Sector-08, Rohini, Delhi-110085, was confirmed by the Delhi Medical Council.
- (xvi) The Order of the Executive Committee in complaint No.2697 of Shri Kadam Singh ALWC (c) Offg Est Officer for commandant 505, Army Base Workshop Pin -900106 seeking verification of genuineness of medical certificate issued by Dr. R. S. Sharma to Shri Krishan Kumar, was confirmed by the Delhi Medical Council.



- (xvii) The Order of the Disciplinary Committee in complaint No.2127-a representation from police, seeking medical opinion in respect of death of Smt. Arti alleging due to negligence in the treatment administered to late Arti resulting in her death on 19.04.2015 at DDU Hospital, was confirmed by the Delhi Medical Council.
- (xviii) The Order of the Disciplinary Committee in complaint No.1837 of Shri Rajkumar Pathak r/o- D.R.D.O. Bhawan, Rajaji Marg, New Delhi, alleging medical negligence on the part of doctors of Deen Dayal Upadhyay Hospital, Hari Nagar, Ghanta Ghar, Clock Tower, New Delhi-110064, in the treatment administered to the complainant's son Shri Akhilesh Pathak, resulting in his death, was taken up for confirmation before the Delhi Medical Council.

Whilst confirming the Order of the Disciplinary Committee, the Council observed that in this case, no medical negligence can be attributed on the part of doctors of Deen Dayal Upadhyay Hospital, in the treatment administered to the complainant's son Shri Akhilesh Pathak. The Council further directed that a copy of this Order be also sent to the Principal Secretary (H&FW), Department of Health Welfare, Govt. of NCT of Delhi with a request that necessary direction/step be taken to address the shortcoming highlighted in the Order of the Disciplinary Committee.

This observation is to be incorporated in the final Order to be issued. The Order of the Disciplinary Committee stands modified to this extent and the modified Order is confirmed.

- (xix) The Order of the Disciplinary Committee in complaint No.1786 of Shri Sarbeshwar Nayak r/o- 88A, Pocket-A, Dilshad Garden, Delhi, forwarded by the Deputy Commissioner of Police, North-East District, Delhi, alleging medical negligence on the part of doctors of Jeevan Jyoti Clinic and Hospital, G.T.B Chowk, Dilshad Garden, Delhi-110095 in the treatment administered to the complainant's wife Smt. Gitanjali Nayak, resulting in her death on 21.11.2014 at Jeevan Jyoti Clinic and Hospital, was confirmed by the Delhi Medical Council.



- (xx) The Order of the Disciplinary Committee in complaint No. 2414 of Shri Parminder s/o late Shri S. Harbans Singh, Chamber No.4, Post Office Lane, Tis Hazari Courts, Delhi-110054, forwarded by the Directorate General of Health Services, Govt. of NCT of Delhi, seeking verification of genuineness of a medical certificates issued by Dr. D.K. Satija of Adarsh Nursing Home, 153-154, Raja Garden, New Delhi-110015, Delhi to one Shri Manjit Singh, was confirmed by the Delhi Medical Council.

The Council further directed that criminal prosecution be initiated against Dr. D.K. Satija under Section 27 of the Delhi Medical Council Act, 1997.

This observation is to be incorporated in the final Order to be issued. The Order of the Disciplinary Committee stands modified to this extent and the modified Order is confirmed.

- (xxi) A complainant No.1705 of Shri Hukum Chand Bansal, r/o- B-45, Sindhu Farm Road, Meetha Pur Vistar, Badarpur, New Delhi-110044, forwarded by Public Grievance Monitoring System, Govt. of NCT of Delhi, alleging negligence on the part of CRL Diagnostic Pvt. Ltd., 5, Ashoka Park Main, Rohtak Road, Near Ashoka Park Main, Delhi-110035, in preparation of blood test reports of the complainant's wife Smt. Phoolwati, was confirmed by the he Delhi Medical Council.

The Council further observed that in case of alarming result beside the same being communicated to the patient, it should also brought to the notice of the referring doctor.

The Order of the Disciplinary Committee stands modified to this extent and the modified Order is confirmed.

- (xxii) The Order of the Disciplinary Committee in complaint No.1938- a representation from Police, seeking medical opinion in respect of treatment administered to Smt. Saba Bano, resulting in birth of still born baby at Aruna Asaf Ali Govt.

Hospital, allegedly due to medical negligence on the part of doctors of Aruna Asaf Ali Govt. Hospital, was taken up for confirmation before the Delhi Medical Council.

Whilst confirming the Order of the Disciplinary Committee, the Council observed that the Medical Superintendent of Aruna Asaf Ali Govt. Hospital, should make a protocol that in all cases where the residents have any doubt regarding diagnosis or the treatment, they should discuss the same or bring it to the notice of the consultant, to ensure that the patient receive the best available medical advice treatment.

The Council further directed that a copy of this Order be also sent to the Directorate General of Health Services, Govt. of NCT of Delhi for information and necessary action.

This observation is to be incorporated in the final Order to be issued. The Order of the Disciplinary Committee stands modified to this extent and the modified Order is confirmed.

- (xxiii) The Order of the Disciplinary Committee in complaint No.1941 of Smt. Savita Srivastava, r/o- 434, vikas Kunj, Outer Ring Road, Vikas Puri, New Delhi-110018, alleging medical negligence on the part Dr. Suneet Khetarpal of Apollo Clinic, C-70, Major Sudesh Kumar Marg Opp. Madhav Park, Near Main Market, Rajouri Garden, New Delhi-11007, in the preparation of ultrasound report of the complainant, was confirmed by the Delhi Medical Council.
- (xxiv) The Order of the Disciplinary Committee in complaint No.2530 of Shri Rajan Sharma s/o Shri Swarn Sharma r/o- 1/2572, Paras Apartment, Shahdara, Delhi-110032, alleging medical negligence on the part of doctors of East Delhi Medical Centre, 1/550, G.T. Road, Mansarovar Park, Shahdara, Delhi-110032, in the treatment administered to complainant's sister Miss. Reeta Sharma at East Delhi Medical Centre, was confirmed by the Delhi Medical Council.

- (xxv) The Order of the Disciplinary Committee in complaint No.2387-an order dated 22.11.2017, in matter titled State Vs. Suresh Malik & Ors (SC No.718/16, FIR No. 618/14, P.S. Jyoti Nagar) passed by Hon'ble Court of Additional Sessions Judge-3, Room No. 58, 3<sup>rd</sup> Floor, Karkardooma Court, Delhi, wherein certain observation have been made against Dr. Gajinder Nayyar, was confirmed by the Delhi Medical Council.

The Council also confirmed the punishment of removal of name awarded to Dr. Gajinder Nayyar (Dr. Gajinder Kumar Nayyar, Delhi Medical Council under registration No.36089) by the Disciplinary Committee.

The Council further observed that the Order directing the removal of name from the State Medical Register of Delhi Medical Council shall come into effect after 30 days from the date of the Order.

The Order of the Disciplinary Committee stands modified to this extent and the modified Order is confirmed.

- (xxvi) The Order of the Disciplinary Committee in complaint No.2621-an Court Order dated 22.10.2018 in C.C. No. 7174-16, 7153-16, 7046-16, 7039-16, 7038-16, 7037-16, in which certain observation made by the learned Metropolitan Magistrate, in regard to medical certificate issued by Dr. Neeraj Aggarwal to one Shri Amarjeet Singh, was confirmed by the Delhi Medical Council.

The Council also confirmed the punishment of removal of name awarded to Dr. Neeraj Agarwal (Delhi Medical Council Registration No.4402) by the Disciplinary Committee.

The Council further observed that the Order directing the removal of name from the State Medical Register of Delhi Medical Council shall come into effect after 30 days from the date of the Order.



The Order of the Disciplinary Committee stands modified to this extent and the modified Order is confirmed.

(xxvii) The Order of the Disciplinary Committee in complaint No.1775 of Sh. Premdatt Chopra, r/o- 937, Sector-A, Pocket-C, Vasant Kunj, New Delhi alleging medical negligence on the part of doctors of Fortis Lt. L.T. Rajan Dhall Hospital, Sector-B, Pocket-1, Aruna Asaf Ali Marg, Vasant Kunj, New Delhi-110070, in the treatment administered to the complainant's wife Mrs. Ish Chopra at Fortis Lt. L.T. Rajan Dhall Hospital, resulting in her death at Max Hospital, where she was subsequently treated, was confirmed by the Delhi Medical Council.

(xxviii) The Order of the Disciplinary Committee in complaint No.1453- a representation from SHO, Police Station Saket, Delhi, seeking medical opinion on a complaint of Shri Naman Jindal, r/o, H. No. 2, VIP Colony, Rampur, Uttar Pradesh, alleging medical negligence on the part of Dr. Pradeep K. Chaubey, Dr. Vandana Soni and Max Super Speciality Hospital, Saket, New Delhi-110017, in the treatment administered to the complainant's father late Navneet Jindal at Max Super Speciality Hospital, resulting in his death on 22.1.2014, was taken up for confirmation before the Delhi Medical Council.

Whilst confirming the Order the Disciplinary Committee, the Council observed that in the facts and circumstances of this case, the interests of justice will be served if a warning be issued to Dr. Pradeep Kumar Chowbey (Delhi Medical Council Registration No.11827), Dr. Vandana Soni (Dr. Vandana Mann Soni, Delhi Medical Council Registration No.35334) and Dr. Aparna Sinha (Dr. Aparna Sinha Agarwal, Delhi Medical Council Registration No.3199), hence, a warning is issued to Dr. Pradeep Kumar Chowbey (Delhi Medical Council Registration No.11827), Dr. Vandana Soni (Dr. Vandana Mann Soni, Delhi Medical Council Registration No.35334) and Dr. Aparna Sinha (Dr. Aparna Sinha Agarwal, Delhi Medical Council Registration No.3199).

This observation is to be incorporated in the final Order to be issued. The Order of the Disciplinary Committee stands modified to this extent and the modified Order is confirmed.

A meeting of the Anti Quackery Committee of the Delhi Medical Council was held on 28<sup>th</sup> December, 2018 at 3:00 p.m. in the office of Delhi Medical Council

1. **Shri S.A. Khan:-** Shri S.A. Khan neither replied nor appeared before the Anti Quackery Committee in response to Show Cause Notice No. DMC/AQ/F.3-A/SCNs/2/2018/278173 dated 14<sup>th</sup> December, 2018. The Anti-Quackery Committee noted that notice sent to Shri S.A. Khan returned undelivered in the office of Delhi Medical Council with noting from the Postal Department "No Such Person Found".

In light of the above, the Anti-Quackery Committee directed that the concerned CDMO (North East District) be asked to provide complete and correct address of Shri S.A. Khan to the office of Delhi Medical Council. Once the same is received, show cause notice again be issued to Shri S.A. Khan.

2. **Mrs. Shanta Kumari Julka:-** Mrs. Shanta Kumari Julka neither replied nor appeared before the Anti Quackery Committee in response to Show Cause Notice No. DMC/AQ/F.3-A/SCNs/2/2018/278174 dated 14<sup>th</sup> December, 2018. On examining of the inspection report no. F.No.3/11/2015/AQIII/SHD/2532-34 dated 5/12/2018 of the Chief District Medical Office (Shahdara District), in respect of Mrs. Shanta Kumari Julka, the Anti Quackery Committee noted that Mrs. Shanta Kumari Julka, has been practicing allopathy without holding any requisite medical qualification as enumerated in the Schedules I, II, III of the Indian Medical Council Act 1956, entitling him to practice in allopathy and also not being registered with the Delhi Medical Council, in violation of the Section 15(6) of the Delhi Medical Council Act, 1997.



In light of the above, the Anti Quackery Committee, hereby, in exercise of powers conferred under section 10(h) of the Delhi Medical Council, Act, 1997 recommends that Mrs. Shanta Kumari Julka, be directed to stop practicing allopathy, forthwith, and to close down his Clinic and Anti Quackery Committee also decided that the police be requested to register a FIR under Section 27 of Delhi Medical Council Act, 1997 alongwith relevant Section of IPC.

3. **Ms. Rekha:-** Ms. Rekha neither replied nor appeared before the Anti Quackery Committee in response to Show Cause Notice No. DMC/AQ/F.3-A/SCNs/2/2018/278175 dated 14<sup>th</sup> December, 2018. The Anti-Quackery Committee noted that notice sent to Ms. Rekha returned undelivered in the office of Delhi Medical Council with noting from the Postal Department "Incomplete Address".

In light of the above, the Anti-Quackery Committee directed that the concerned CDMO (West District) be asked to provide complete and correct address of Ms. Rekha to the office of Delhi Medical Council. Once the same is received, show cause notice again be issued to Ms. Rekha.

4. **Shri Manojit Kumar Nath:-** Shri Manojit Kumar Nath appeared before the Anti-Quackery Committee and submitted a reply. The reply submitted by Shri Manojit Kumar Nath was found to be unsatisfactory in response to Show Cause Notice No. DMC/AQ/F.3-A/SCNs/2/2018/278176 dated 14<sup>th</sup> December, 2018. On examination of the inspection report no. F.20(1)/Antiquackery/DHS/WD/2003/4684-4687 dated 3/12/2018, of the Chief District Medical Office (West District), in respect of Shri Manojit Kumar Nath, the Anti Quackery Committee noted that Shri Manojit Kumar Nath, has been practicing allopathy without holding any requisite medical qualification as enumerated in the Schedules I, II, III of the Indian Medical Council Act 1956, entitling him to practice in allopathy and also not being registered with the Delhi Medical Council, in violation of the Section 15(6) of the Delhi Medical Council Act, 1997.

In light of the above, the Anti Quackery Committee, hereby, in exercise of powers conferred under section 10(h) of the Delhi Medical Council, Act, 1997 recommends that Shri Manojit Kumar Nath, be directed to stop practicing allopathy, forthwith, the police be requested to register a FIR under Section 27 of Delhi Medical Council Act, 1997 alongwith relevant Section of IPC.



5. **Dr. Vinod Kumar Gupta:-** Dr. Vinod Kumar Gupta appeared before the Anti-Quackery Committee and submitted a reply. The reply submitted by Dr. Vinod Kumar Gupta was found to be unsatisfactory in response to Show Cause Notice No. DMC/AQ/F.3-A/SCNs/2/2018/278244 dated 14<sup>th</sup> December, 2018.

During the enquiry, it has also come to the notice of the Anti-Quackery Committee that Dr. Vinod Kumar Gupta who is registered with the Delhi Medical Council under the registration No.15329 dated 31<sup>st</sup> May 2002, (Valid up to 9<sup>th</sup> August 2022) has been associating in connection with his professional practice with Shri Manojit Kumar Nath @ Manmotho Kumar Devnath who is an unqualified medical person in flagrant violation of the Regulation 1.6 of the Indian Medical Council (Professional Conduct, Etiquette and Ethics), Regulations, 2002.

In light of the above, the Anti-Quackery Committee recommends that disciplinary action be initiated against Dr. Vinod Kumar Gupta, hence, the matter be refer to Disciplinary Committee of Delhi Medical Council.

6. **Shri Avijit Das:-** Shri Avijit Das neither replied nor appeared before the Anti Quackery Committee in response to Show Cause Notice No. DMC/AQ/F.3-A/SCNs/2/2018/278177 dated 14<sup>th</sup> December, 2018. The Anti-Quackery Committee noted that notice sent to Shri Avijit Das returned undelivered in the office of Delhi Medical Council with noting from the Postal Department "Incomplete Address".

In light of the above, the Anti-Quackery Committee directed that the concerned CDMO (East District) be asked to provide complete and correct address of Shri Avijit Das to the office of Delhi Medical Council. Once the same is received, show cause notice again be issued to Shri Avijit Das.

7. **Shri R.U. Yadav:-** Shri R.U. Yadav neither replied nor appeared before the Anti Quackery Committee in response to Show Cause Notice No. DMC/AQ/F.3-A/SCNs/2/2018/278178 dated 14<sup>th</sup> December, 2018. The Anti-Quackery Committee noted that notice sent to Shri R.U. Yadav returned undelivered in the office of Delhi Medical Council with noting from the Postal Department "Incomplete Address".

In light of the above, the Anti-Quackery Committee directed that the concerned CDMO (East District) be asked to provide complete and correct address of Shri R.U. Yadav to the office of



Delhi Medical Council. Once the same is received, show cause notice again be issued to Shri R.U. Yadav.

On examination of the inspection report no. In light of the above, the Anti Quackery Committee hereby, in exercise of powers conferred under section 10(h) of the Delhi Medical Council Act, 1997 recommends that Shri Praveen Kumar, be directed to stop practicing allopathy, forthwith, and to close down his Clinic and Anti Quackery Committee also decided that the police be requested to register a FIR under Section 27 of Delhi Medical Council Act, 1997 alongwith relevant Section of IPC.
