## ORDER


A complaint of Shri Mohd. Asif, alleging medical negligence on the part of respondent 1 & 2 in the treatment administered to the complainant's wife Smt. Asiya Begum at Shubham Medical Care, resulting in her death, was examined by the Delhi Medical Council. In her reply Dr. Jyoti Jagga has stated that the complainant had made a similar complaint against the respondent No. 1 & 2 to Police Station Rajinder Nagar, which he subsequently withdrew stating that he was fully satisfied with the treatment given to his late wife and there was no negligence on the part of the treating doctors. A copy of the representation of Shri Mohd. Asif addressed to SHO, Police Station Rajinder Nagar, Delhi withdrawing his complaint, was submitted by Dr. Jyoti Jagga alongwith her reply. A notice was sent to the complainant to

verify/confirm the averments made by Dr. Jyoti Jagga in her reply within two weeks of receipt of the notice. No communication was received from the complainant in this regard. It is, therefore, presumed that the averments made by Dr. Jyoti Jagga, referred hereinabove, are true and correct. In view of the same, the complaint stands dismissed.


