Sir.


This is in continuation to my complaint dated 4.6.04, duly receiptes by you, I wish to bring to yours knowledge the facts of the case in details.

On 21-05-2004 My wife Mrs. Anju Shelly (Who was pregnant) along with my mother visited Veena Nursing Home, For a regular check up. At the relevent time my wife was normal & was not having any probler A Veena Nursing Home, Dr. Veena Aggarwal after examining my wife informes my mother that the condition of my wifewas serious & an immediate operation was required to save the child and my wife.

Thereafter Dr. Veena Aggarwal asked my mother to arrange 8-10 thousand rupees and deposit the same at cash counter. My mother who was shocked with the sudden change of circumstances calles at my mobile and asked me to arrange for money which I did.

Before I could reach the Nursing Home & Devoted the money Dr. Veena Aggarwal Conducted the operation & thereafter informed my mother & Mama who had reached by them, That my wife had deliveres a baby girl. At the time of Conducting the operation Dr. Vee Aggarwal was assisted by 3 others Doctors, the names of whom are not know to me.

My mother & Mama who were present at the Nursing Home asked Dr. Veena Aggarwal to show the baby to them. However Dr. Veena Aggarwal told them the baby would be shown to them a little later as the baby required some medical AID at that time.



Repeated requests by the Mother & Mama to bring/Show the baby fell on deaf ears and Dr. Veena lingered on the matter on one pretext or the other.

My wife was shifted to Room No. 102 at about 6:45 at about 7:00 the baby was brought there in said room. The conduct of Dr. Veena and the staff of Veena Nursing Home all throughout was very odd & pointout that something fishy was going on.

On 24-05-2004 My wife & child was discharged from the nursing home. Thereafter my wife visited the nursing on 29-05-2004 for check up & again 01-06-2004.

On 01-06-2004 the Nursing Home Staff gave a slip which was duty signed by Dr. Veena Aggarwal Indicating that my wife had deliveres a Baby Boy i.e. A male child & not a female baby as advised to my mother & mama by Dr. Veena Aggarwal. It is important to note then my wife was made to sign a paper indicating that she delivered a Baby Girl. The fact that the slip mentioned about the birth of a male child came to my & my wife Knowledge when we scrutinized the slip at home.

On 02-06-2004 I visites Veena Nursing Home to meet Dr. Veena Aggarwa at about 10:30 A.M.. Dr. Veena Aggarwal avoides meeting me but becaus of my insisting attitude, finally I could meet her at about 11:30 - 11:45 A.M. & I requestes her to give me the report of the last Ultrasound which she refused. I had to return back home in a state of frustration. That since I was not in proper mental frame, I could not approach yourgoodself for necessary action.

From the facts & circumstances, it in a clear case of child swapping. I Request you to Lodge an FIR against the said Dr. Veena Aggarwal & her assistant Doctors under the provisions of IPC & take necessary action against them & Bring the guilty to books Hoping for an immediate action.
