

ORDER

WHEREAS upon a complaint of Shri P.N. Mishra, B-Block, Sant Nagar, Delhi-110084, forwarded by Medical Council of India, alleging indulgence in the practice of quackery by Shri R.K. Pathak, Pathak Medical Care, Gali No. 14, Sant Nagar (25th Ft. Burari Jharonda Road), Sant Nagar, Delhi - 110084. A notice to show cause No. DMC/13-A/AQ-F.2/2/2007/32778 dated 6th August, 2007 was issued to Shri R.K. Pathak who practices allopathy at Pathak Medical Care, Gali No. 14, Sant Nagar (25th Ft. Burari Jharonda Road), Sant Nagar, Delhi - 110084, directing Shri R.K. Pathak to stop practicing allopathy and to appear before the Delhi Medical Council on 16th August, 2007 to show cause against the Order.

WHEREAS Shri R.K. Pathak on presenting before Delhi Medical Council could neither produce any recognized qualification or valid registration entitling him to practice allopathy nor could offer any satisfactory explanation to the aforesaid notice and was also found to be not registered with the Delhi Medical Council, in violation of section 15(6) of the Delhi Medical Council Act, 1997; thus, the Delhi Medical Council, hereby, in exercise of the powers conferred under section 10(h) of the Delhi Medical Council Act through this Order directs Shri R.K. Pathak to stop practicing allopathy, forthwith, and to close down his Pathak Medical Care, Gali No. 14, Sant Nagar (25th Ft. Burari Jharonda Road), Sant Nagar, Delhi - 110084.
