RULES FOR FOREIGN MEDICAL GRADUATES FOR CRMI REGULATION 2021

1. The Foreign Medical Graduates who are willing to start the internship in NCT of Delhi and are **RESIDENT OF DELHI HOLDING THE PASSPORT AND AADHAR CARD HAVING THE DELHI ADDRESS ONLY** are eligible for Internship Training and the application are accepted only on pro rata basis, based on total no of seats available in Hospitals/Medical Colleges in NCT of Delhi.
2. The Foreign Medical Graduates are required to fill the online form under the link <https://forms.gle/F2eVfXSKmgKQ5Am27> latest by 15th September, 2026 (04.00 PM), to be considered for Internship Training and the application are accepted only on pro rata basis, based on total no of seats available in Medical Colleges in NCT of Delhi. 3. The applicant has to come physically to fill the attached Performa and submit the same at Delhi Medical Council. The schedule for document verification will be announced separately. Applicants will be called accordingly to submit the attached Performa along with their original documents at the office.
4. Delhi Medical Council will scrutinize all the applications and shall prepare the Merit list considering CRMI Regulations 2021 (based on the criteria mentioned below) and the same will be published on the website of Delhi Medical Council.
5. The candidates who make up the Merit List will be eligible to apply for provisional registration with Delhi Medical Council online; within 10 days from publication of such list and link to apply for provisional registration (Foreign Medical Graduates) will be active on our website www.delhimedicalcouncil.org after the publication of such list.
6. The selected candidates have to join the internship program immediately but not later than 07 days from the date on which the final list is uploaded on the official website of Delhi Medical Council failing which the seat will be considered vacant and will be allotted to next eligible candidates as per Merit List, who meet the necessary criteria.
7. No request for a change of hospital/college for internship will be entertained after the publication of the Merit list.

8. Delhi Medical Council has the right to reject any application in case it doesn't fulfil the criteria or the applications received are more than the seats available in Hospital/medical colleges in Delhi.
9. The amount of stipend to be paid to the interns is to be decided/fixed by the appropriate authority and is solely at the discretion of the concerned authorities under which the medical college/institute is located and Delhi Medical Council does not bear any liability in this regard.

CRITERIA FOR PREPARING MERIT LIST

Merit list will be prepared based on NBE score of Screening Test Result obtained by the candidate and in case more than one candidate with same score, merit will be determined on the basis of following criteria:-

- a. Candidate who has secured higher percentage in subjects of Physics, Chemistry, Biology (PCB) marks in (10+2) examinations.
- b. Candidates who has secured higher percentage in subject of Biology marks in 10+2 examinations
- c. Candidate who is older.

The applicant must submit the required documents in person, along with the duly filled Performa, at the office **only after** the document verification date is officially announced. No documents should be submitted at this time, and DMC will not accept any requests for document verification before the published date.

1. Self attested copy of Passport and Aadhar card as residence proof.
2. Self attested Screening Test Passing Certificate.
3. Self attested copy of 10+2 Mark sheet issued from CBSE or equivalent Board.
4. Self attested copy of Delhi Medical Council Provisional Registration Certificate (if any).
6. The Application may be rejected if any discrepancy found in Performa and the documents submitted.

Note :- Candidate have to bring original passport, original Aadhar card, Original Screening Test Passing certificate and 10+2 for verification

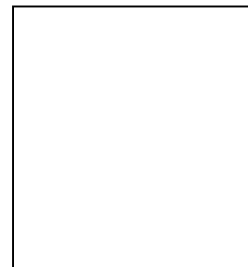
