


3. To discuss cases of medical negligence and unethical conduct.

- (a) The Order of the Executive Committee in complaint No. 2964 of Smt. Amrita Chopra 40, Shanti Vihar Vikas Marg Extn. New Delhi -110092 alleging medical negligence on the part of Dr. A.K. Mittal, Shivam Surgical & Maternity Centre 30, Shanti Vihar, Delhi-110092, in the treatment of complainant, was confirmed by the Delhi Medical Council.
- (b) The Order of the Executive Committee in complaint No. 3009-a representation from Police Station, Civil Lines, Delhi, seeking medical opinion in respect of death of Shri Teetu @ Dinesh s/o Shri Jaswant Singh, r/o- House No.52/AC-44, Gali No. 17, Aanand Parvat, New Delhi, allegedly due to medical negligence in the treatment administered to Shri. Teetu at Sushruta Trauma Centre, 9 Metcalf Road, Delhi-110054, resulting in his death on 04.10.2011, was confirmed by the Delhi Medical Council.
- (c) The Order of the Executive Committee in complaint No.3092- a representation from Police Station, North Avenue, New Delhi seeking medical opinion on a complaint of Smt. Kiran Sahni, r/o- House No. X-2971, Gali No.01, Brahmpuri, New Delhi, alleging medical negligence on the part of doctor of Dr. Ram Manohar Lohia Hospital, New Delhi-110001, in the treatment administered to the complainant, was taken up for screening before the Executive Committee of the Delhi Medical Council,, was confirmed by the Delhi Medical Council.

Dr. Rajeev Sood recused himself from the proceeding.

Sushil Bihani, B-184, Okhla Industrial Area-I, New Delhi-110024, in respect of treatment administered by Shri Biswaroop Roy Chaudhary to the complainant's mother late Smt. Shanta Bihani, resulting in her death, was confirmed by the Delhi Medical Council.
- (e) The Order of the Executive Committee in complaint No.2976-a representation from police station, Paschim Vihar East; Outer District; Delhi, seeking medical opinion on a complaint of Smt. Shalini Chauhan, F-53, DDA Colony Khyala, New Delhi-110018, alleging medical negligence on the part of doctors of Sri Balaji Action Medical Institute, A-4, Paschim Vihar, New Delhi-110063, in the treatment administered to complainant, was confirmed by the Delhi Medical Council.
- (f) The Order of the Executive Committee in complaint No.3192-a representation from Dy. Commissioner of Police Central District seeking medical opinion in respect of death of Shri Surender Kumar allegedly due to medical negligence in the treatment administered at Fortis Hospital Shalimar Bagh, Delhi, was confirmed by the Delhi Medical Council.

Dr. Arun Kumar Gupta recused himself from the proceedings.

Babita Garg, A-3/117, Sector-03, Rohini, New Delhi-110085, alleging negligence in the preparation/examination of x-ray reports of complainant on the part of Dr. G.S. Garkal, Janta Diagnostic Centre, 12/404, Sunder Vihar, Main Outer Ring Road, New Delhi-110085, was confirmed by the Delhi Medical Council.
- (h) The Order of the Executive Committee in complaint No.3098 of Shri Dindayal Shaw, r/o-B-9, Jiwan Park 80, Gaj Colony, Livaspur, Delhi-110042, forwarded by Directorate General of Health Services, Govt. of NCT of Delhi, alleging medical negligence on the part of doctors of Mahajan Eye Centre, AD-21A, Pitampura, Delhi, in the treatment administered to the complainant, was confirmed by the Delhi Medical Council.

- (i) The Order of the Executive Committee in complaint No.2660-a reference from Directorate General of Health Services, Govt. of NCT of Delhi, seeking investigation into complaint of Shri Ghulam Qadir Dhar r/o- Banamsar, Sonwar Bagh, Sri Nagar, Kashmir 190001 against Lama Medical Centre, Malviya Nagar, New Delhi, was confirmed by the Delhi Medical Council.
- (j) The Order of the Executive Committee in complaint No. 3339 of Shri Ankur Jain, D-2/20, Janakpuri, New Delhi-110058, alleging medical negligence on the part of doctors of Venkateshwar Hospital Sector-18A, Dwarka, New Delhi, in the treatment of complainant's father Shri Sandeep Kumar, resulting in his death on 29.05.2021, was confirmed by the Delhi Medical Council.
- (k) The Order of the Executive Committee in complaint No.2827 of Ms. Nidhi Jain, r/o- 9/1989, Street No.04, Kailash Nagar, Delhi-110031, alleging medical negligence on the part of Dr. A.K. Dhal and Lok Nayak Hospital, Delhi Gate, Delhi-110002, in the treatment administered to complainant, was confirmed by the Delhi Medical Council.
- (l) The Order of the Executive Committee in complaint No.2943-a representation from police station, Malviya Nagar, New Delhi, seeking medical opinion on a complaint of Shri Karampal, V.P.O Ranwar, Tehsil & District-Karnal 132001(Haryana), alleging medical negligence on the part of doctors of Akash Hospital, 90/43, Malviya Nagar, New Delhi-110017 and Max Smart Super Specialty Hospital, Saket, New Delhi-110017, in the treatment of complainant's son Mr. Porus Bhangray, resulting in his death, was confirmed by the Delhi Medical Council.
- (m) The Order of the Executive Committee in complaint No. 3144-a representation from Dy. Commissioner of Police, West District, Delhi, seeking medical opinion on a complaint of Smt. Harjeet Kaur r/o Village Possangipur, Janakpuri, alleging medical negligence on the part of the doctors of Mata Chanan Devi Hospital, C-1, Janakpuri, New Delhi-110058, in the treatment of the complainant's son Shri Gagandeep, resulting in his death on 11.02.2020 at Safdarjung Hospital, New Delhi, where he subsequently received treatment, was confirmed by the Delhi Medical Council.
- (n) The Order of the Disciplinary Committee in complaint No.2783- a representation from police, seeking medical opinion on a complaint of Shri Pradeep Kumar s/o late Shri

Gyanchand r/o J-1076 Mangolpuri, Delhi-110083, alleging medical negligence in the treatment administered to complainant's wife Smt. Babita at Prashanti Nursing Home, H-32/9, Sector-3, Rohini, Delhi-110085, was confirmed by the Delhi Medical Council.

The Council also confirmed the punishment of warning awarded by the Disciplinary Committee to Dr. Naval Kishore Uniyal (Delhi Medical Council Registration No.16048).

- (o) The Order of the Disciplinary Committee in complaint No.2038 of Smt. Archana, House No.3011, Gali No.2, Dharampura, Delhi, forwarded by the Public Grievance Monitoring System, Govt. of NCT of Delhi, alleging medical negligence on the part of Dr. Vinay Gupta and Dr. Meenakshi of Singhal Nursing Home, IX/3, Main Road, Kailash Nagar, Delhi-110031, in the preparation/conduct of USG scan report dated 13.02.2017, was taken up for confirmation before the Delhi Medical Council.

Whilst confirming the Order of the Disciplinary Committee, the Council observed that since Dr. Vinay Gupta has been misrepresenting his qualifications; the punishment of warning awarded by the Disciplinary Committee to Dr. Vinay Gupta will not serve the interest of justice, hence, the Council directs that punishment awarded to Dr. Vinay Gupta be enhanced and the name of Dr. Vinay Gupta (Delhi Medical Council Registration No.21327) be removed from the State Medical Register of the Delhi Medical Council for a period of 30 days.

The Council further observed that the Order directing the removal of name from the State Medical Register of Delhi Medical Council shall come into effect after 30 days from the date of the Order.

This observation is to be incorporated in the final Order to be issued. The Order of the Disciplinary Committee stands modified to this extent and the modified Order is confirmed.

- (p) The Order of the Disciplinary Committee in complaint No.2037 of Shri Kuldeep Singh s/o Late Sh. Prem Singh r/o-Village Jondhan Kalan, The Israna, District Panipat, Haryana, alleging medical negligence on the part of Dr. Alok Aggarwal, Dr. Anuj Kumar Gupta and Maharaja Agrasen Hospital, Panjabi Bagh New Delhi-110026, in the treatment administered to the complainant's father Shri Prem Singh, resulting in his death, was confirmed by the Delhi Medical Council.

Dr. Maneesh Singhal recused himself from the proceedings.

- (q) The Order of the Disciplinary Committee in complaint No.2540- a representation from the police station Subzi Mandi North Distt. Delhi, seeking medical opinion on a complaint of Shri Rajesh r/o H.No.295, Katra Gulkhan Subzi mandi, Delhi, alleging medical negligence Ujagar Mal Chander Bhan Charitable Medical Centre, 96-A, Kamla Nagar, First Floor, Delhi-110007 and St. Stephan Hospital Tis Hazari in the treatment of complainant's wife Smt. Geeta, resulting in her death on 22.03.2017 at St. Stephan Hospital Tis Hazari, New Delhi-110054, was taken up for confirmation before the Delhi Medical Council.

Whilst confirming the Order of the Disciplinary Committee, the Council observed that since Dr. Piyooshi Sharad has been misrepresenting her qualifications; the punishment of warning awarded by the Disciplinary Committee to Dr. Piyooshi Sharad will not serve the interest of justice, hence, the Council directs that punishment awarded to Dr. Piyooshi Sharad be enhanced and the name of Dr. Piyooshi Sharad (Delhi Medical Council Registration No.1024) be removed from the State Medical Register of the Delhi Medical Council for a period of 30 days.

The Council further observed that the Order directing the removal of name from the State Medical Register of Delhi Medical Council shall come into effect after 30 days from the date of the Order.

This observation is to be incorporated in the final Order to be issued. The Order of the Disciplinary Committee stands modified to this extent and the modified Order is confirmed.

- (r) The Order of the Disciplinary Committee in complaint No. 2796 of Shri O.P. Swami, r/o-D-184, Shyam Vihar, PH-1, Main Road No. 06, Goyla Road Najafgarh, New Delhi-110043, alleging medical negligence on the part of Dr. Pushpender Sachdeva of Venkateshwar Hospital, Sector-18 A, Dwarka, New Delhi in the treatment administered to complainant's wife Smt. Meera Devi, was confirmed by the Delhi Medical Council.
- (s) The Order of the Disciplinary Committee in complaint No. 2932 -in terms of the order dated 03.9.2019 of Hon'ble Addl. Chief Metropolitan Magistrate Distt. Courts Complex, Karkardooma, Delhi, in CC no. 49921/16 in complaint of Shri Meshar Ali s/o Shri

Shaukat Ali, r/o C-99, Kabutar Market, Welcome, Seelampur, Delhi, alleging medical negligence in the treatment administered to the complainant's wife Smt. Allah Rakhi at Taneja Nursing Home(Dr. Raushan Lal Hospital Pvt. Ltd.) F-15, Preet Vihar, Vikas Marg, Delhi-110092, resulting in her death on 11.5.2011 at GTB Hospital, was confirmed by the Delhi Medical Council.

- (t) The Order of the Disciplinary Committee in complaint No.2425 of Ms. Kavita Kumari d/o Shri Ram Charan Meena r/o H.No.552/2B, Veer Bazar Road Wali Gali, Kapashera, Delhi, forwarded by Delhi Commission for Women, alleging medical negligence on the part of doctors of Safdarjung Hospital, in the treatment of complainant, was confirmed by the Delhi Medical Council, was taken up for confirmation before the Delhi Medical Council.

Dr. Manish Kumath recused himself from the proceedings.

Whilst confirming the Order of the Disciplinary Committee, the Council observed that in the facts and circumstances of this case, the punishment of removal of name of Dr. Rahul Kumar awarded by the Disciplinary Committee from the State Medical Register of the Delhi Medical Council for period of 90 days was a bit harsh punishment and interests of justice will be served, if the name of Dr. Rahul Kumar is removed from the State Medical Register of the Delhi Medical Council for a period of 30 days; hence, the Council directs that the name of Dr. Rahul Kumar (Delhi Medical Council Registration No.DMC/R/8055) be removed from the State Medical Register of the Delhi Medical Council for period of 30 days. The Council also confirmed the punishment of removal of name of Dr. Arun Kumar (Delhi Medical Council Registration No.DMC/R/15250) for a period of 15 days awarded by the Disciplinary Committee. The Council further confirmed the punishment of warning awarded to Dr. Davinder Singh (Delhi Medical Council Registration No.19029), Dr. Ankit Kumar Jain (Delhi Medical Council Registration No.80733), Dr. Kumar Keshav(Delhi Medical Council Registration No.DMC/R/5400), Dr. Kanishk Bansiwal(Delhi Medical Council Registration No.DMC/R/10998), Dr. Keshav Goel (DMC No.77639) and Dr. Shashank Singh (Delhi Medical Council Registration NoDMC/R/15026) by the Disciplinary Committee. In addition, all the above named doctors shall undergo 20 hours of C.M.E. (Continuing Medical Education) on the subject "Ortho Trauma Surgery", within a period of three months and submit a compliance report to this effect to the Delhi Medical Council.

The Council further observed that the Order directing the removal of name from the State Medical Register of Delhi Medical Council shall come into effect after 30 days from the date of the Order.

This observation is to be incorporated in the final Order to be issued. The Order of the Disciplinary Committee stands modified to this extent and the modified Order is confirmed.

- (u) The Order of the Disciplinary Committee in complaint No. 2892 of Shri Vikas Gupta s/o Shri Ram Prakash Gupta r/o D-14/138, Sector-3, Rohini, Delhi-110085, forwarded by Minister of Health, Govt. of NCT of Delhi, alleging medical negligence on the part of Dr. Arun Garg, Dr. Pratibha Garg, Dr. Vivek Mangla of Swastik Maternity Centre, G-20/23-24, Sector-7 Rohini, Delhi-110085, in the treatment of complainant's daughter Baby Manasvi Gupta, resulting in her death on 8.6.2019 at Ganga Ram Hospital where she subsequently received treatment, was confirmed by the Delhi Medical Council.

The Council also confirmed the punishment of removal of name of Dr. Vivek Mangla (Dr. Vivek Kumar Mangla, Delhi Medical Council Registration No.17785) from the State Medical Register of the Delhi Medical Council for a period of 30 days awarded by the Disciplinary Committee with a direction that he shall undergo 20 hours of C.M.E.(Continuing Medical Education) on the subject "Peri-operative anesthetic management" during the period of suspension and submit a compliance report to this effect to the Delhi Medical Council.

The Council further observed that the Order directing the removal of name from the State Medical Register of Delhi Medical Council shall come into effect after 30 days from the date of the Order.

This observation is to be incorporated in the final Order to be issued. The Order of the Disciplinary Committee stands modified to this extent and the modified Order is confirmed.

- (v) The Order of the Disciplinary Committee in complaint No. 1583- a complaint of Ms. Anjali Gopalan, Executive Director, The Naz Foundation (India) Trust, A-86, East of Kailash, alleging professional misconduct on the part of the doctors for using hormone therapy, shock treatment and other medications on homosexuals by treating homosexuality

as a disease, as was reported in a news telecast on the India Today Channel on 27th May, 2015, was confirmed by the Delhi Medical Council.

- (w) The Order of the Disciplinary Committee in complaint No.2117 of Shri Sayed Abdul Halim Akhtar r/o H.No.F-126, Satbari Karak, Vill. Chattarpur, New Delhi-110074, alleging medical negligence on the part of Dr. Vijay Hungloo of Batra Hospital, Tughlakabad Institutional Area, Mehrauli Badarpur Road, New Delhi-110062, in the treatment administered to the complainant at Batra Hospital, was confirmed by the Delhi Medical Council.
- (x) The Order of the Disciplinary Committee in complaint No.2686- a representation from SHO, Police Station, NF Colony, Delhi seeking medical opinion on a complaint of Shri. Priya Ranjan Kumar, r/o- House No E-7 Roop Nagar, Tanki Road Badarpur, Delhi , alleging medical negligence on the part of doctors of Holy Family Hospital, Okhla Road, New Delhi-110025, in the treatment administered to complainant son Master Rahul Kumar, resulting in his death on 06.10.2018, was confirmed by the Delhi Medical Council.
- (y) The Order of the Disciplinary Committee in complaint No.2089 of Shams Alam r/o N-89, Abul Fazal Enclave –I, Jamia Nagar, New Delhi-110025, alleging medical negligence on the part of Dr. Ashok Seth and Dr. Vijay Kumar, in the treatment administered to the complainant's father late Shri Amir Alam at Fortis Escort Heart Institute, Sarai Jullena, Okhla Road, New Delhi-110025, was confirmed by the Delhi Medical Council.
- (z) The Order of the Disciplinary Committee in complaint No.2103- a representation from the Police Station, Prashant Vihar, seeking medical opinion in respect of death of Smt. Baby w/o Shri Bhag Singh r/o C-81 Shakurpur, Delhi allegedly due to medical negligence in the treatment administered to Late Baby at Bhagwati Hospital, resulting in her death on 24.09.2016, was confirmed by the Delhi Medical Council.

4. To discuss about the Minutes of the Anti Quackery Committee.

The minutes of the meeting of the Anti-Quackery Committee of the Delhi Medical Council held on 21st September, 2021 (**appended herewith as annexure 'B'**) which were circulated to the members present, were confirmed.

5. To discuss about the Minutes of the Finance Committee.

The minutes of the meeting of the Finance Committee of the Delhi Medical Council held on 09th September, 2021 (appended herewith as annexure 'C') which were circulated to the members present, were confirmed.

6. To discuss about the Minutes of the Land & Building Committee.

The Secretary informed that there are no minutes of the Land & Building Committee of the Delhi Medical Council on which discussion is required, as no meeting of the Land & Building Committee of the Delhi Medical Council had been convened.

7. Any other item with permission of Chair.

- (a) The Council observes that some of the Registered Medical Practitioners of the Delhi Medical Council are misrepresenting their qualification/qualifications, even though, the same is/are not recognized qualification as per the Schedules to the Indian Medical Council Act, 1956 and in fact claims themselves to be specialist viz. gynaecologist, sonologist, radiologist, etc. The Council further observes that making a claim of being a specialist without holding a recognized post-graduate qualification in any subject, is clear violation of Regulation 7.20 and 1.4.2 of the Indian Medical Council (Professional Conduct, Etiquette and Ethics), Regulations, 2002. The contents of which are reproduced herein-below, failing which they shall be liable for disciplinary action.

7.20- "A Physician shall not claim to be specialist unless he has a special qualification in that branch".

1.4.2- "Physicians shall display as suffix to their names only recognized medical degrees or such certificates/diplomas and memberships/honours which confer professional knowledge or recognizes any exemplary qualification/achievements."

The Council, therefore, directs that the Registered Medical Practitioners of the Delhi Medical Council should refrain themselves from the violation of the Regulations 7.20 and 1.4.2 of the Indian Medical Council (Professional Conduct, Etiquette and Ethics), Regulations, 2002.

A circular/notification regarding these observations be put on the Delhi Medical Council's website and the same shall also be published in the Delhi Medical Association's Bulletin/leading newspapers of Delhi for sensitizing and cautioning the medical practitioners.

- (b) The Council observes that some of the Registered Medical Practitioners of the Delhi Medical Council who possess the qualification of M.D. "Physician", have been misrepresenting their qualification by suffixing 'M.D' to their names, as the abbreviation of 'M.D.' can only be used by a person who is a holder of post-graduate medical qualification. Further, the qualification with the nomenclature M.D.(Physician) awarded by various medical universities/institutes outside India is equivalent M.B.B.S. qualification in India. The Council further observes that misrepresenting the qualification without holding a recognized post-graduate qualification in any subject, is clear violation of Regulation 7.20 and 1.4.2 of the Indian Medical Council (Professional Conduct, Etiquette and Ethics), Regulations, 2002. The contents of which are reproduced herein-below, failing which they shall be liable for disciplinary action.

7.20- "A Physician shall not claim to be specialist unless he has a special qualification in that branch".

1.4.2- "Physicians shall display as suffix to their names only recognized medical degrees or such certificates/diplomas and memberships/honours which confer professional knowledge or recognizes any exemplary qualification/achievements."

The Council, therefore, directs that the Registered Medical Practitioners of the Delhi Medical Council should adhere to the Regulations 7.20 and 1.4.2 of the Indian Medical Council (Professional Conduct, Etiquette and Ethics), Regulations, 2002. Further, the holders of M.D. (Physician) qualification awarded by various medical universities/institutes outside India should mention in their letter head prescription, certificates, money receipts given to patients, clinic boards, etc. as mention M.D. (physician) equivalent to M.B.B.S.

A circular/notification regarding these observations be put on the Delhi Medical Council's website and the same shall also be published on the Delhi Medical

Association's Bulletin/leading newspapers of Delhi for sensitizing and cautioning the medical practitioners.

A) Following person were served Show Cause Notice to appear before the Anti-Quackery Committee.

1. **Shri Shavez Alam:-** Shri Shavez Alam neither replied nor appeared before the Anti-Quackery Committee in response to Show Cause Notice No.DMC/AQ/F.3-A/SCNs/2/2021/299030 dated 10th September, 2021. The Anti Quackery Committee noted that notice sent to Shri Shavez Alam returned undelivered in the office of Delhi Medical Council with noting from the Postal Department "No Such Person".

In the light of the above the Anti-Quackery Committee directed that the concerned Chief District Medical Officer (North East District) be asked to provide complete and correct address of Shri Shavez Alam to the office of the Delhi Medical Council. Once the same is received, show cause notice again be issued to Shri Shavez Alam.

2. **Shri Biprojit Krishna Das:-** Shri Biprojit Krishna Das neither replied nor appeared before the Anti-Quackery Committee in response to Show Cause Notice No.DMC/AQ/F.3-A/SCNs/2/2021/299031 dated 10th September, 2021. The Anti Quackery Committee noted that notice sent to Shri Biprojit Krishna Das returned undelivered in the office of Delhi Medical Council with noting from the Postal Department "No Such Person".

In the light of the above the Anti-Quackery Committee directed that the concerned Chief District Medical Officer (East District) be asked to provide complete and correct address of Shri Birpojit Krishna Das to the office of the Delhi Medical Council. Once the same is received, show cause notice again be issued to Shri Birpojit Krishna Das.

3. **Shri V K Rai:-** Shri V K Rai neither replied nor appeared before the Anti-Quackery Committee in response to Show Cause Notice No.DMC/AQ/F.3-A/SCNs/2/2021/299032 dated 10th September, 2021. The Anti Quackery Committee noted that notice sent to Shri V K Rai returned undelivered in the office of Delhi Medical Council with noting from the Postal Department "Incomplete Address".

In the light of the above the Anti-Quackery Committee directed that the concerned Chief District Medical Officer (North East District) be asked to provide complete and correct address of Shri V K Rai to the office of the Delhi Medical Council. Once the same is received, show cause notice again be issued to Shri V K Rai.

4. **Shri Mustakim:-** Shri Mustakim neither replied nor appeared before the Anti-Quackery Committee in response to Show Cause Notice No.DMC/AQ/F.3-A/SCNs/2/2021/299033 dated 10th September, 2021. The Anti Quackery Committee noted that notice sent to Shri Mustakim returned undelivered in the office of Delhi Medical Council with noting from the Postal Department "No Such Person".

In the light of the above the Anti-Quackery Committee directed that the concerned Chief District Medical Officer (North East District) be asked to provide complete and correct address of Shri Mustakim to the office of the Delhi Medical Council. Once the same is received, show cause notice again be issued to Shri Mustakim.

5. **Shri Tandra Biswas:-** Shri Tandra Biswas neither replied nor appeared before the Anti-Quackery Committee in response to Show Cause Notice No.DMC/AQ/F.3-A/SCNs/2/2021/299034 dated 10th September, 2021. The Anti Quackery Committee noted that notice sent to Shri Tandra Biswas returned undelivered in the office of Delhi Medical Council with noting from the Postal Department "No Such Person".


In the light of the above the Anti-Quackery Committee directed that the concerned Chief District Medical Officer (North East District) be asked to provide complete and correct address of Shri Tandra Biswas to the office of the Delhi Medical Council. Once the same is received, show cause notice again be issued to Shri Tandra Biswas.

6. **Shri Parveen Biswas:-** Shri Parveen Biswas appeared before the Anti-Quackery Committee and submitted a reply. The reply submitted by Shri Parveen Biswas was found to be unsatisfactory in response to Show Cause Notice No.DMC/AQ/F.3-A/SCNs/2/2021/299035 dated 10th September, 2021. On examination of the inspection report no. F.6/29/2019/DHS/Estt/NED/AQ/888-89 dated 29th June, 2021 received from the office of the CDMO(North East District), in respect of Shri Parveen Biswas the Anti Quackery Committee noted that Shri Parveen Biswas has been practicing allopathy without holding any requisite medical qualification as enumerated in the Schedules I, II, III of the Indian Medical Council Act 1956, entitling him to practice in allopathy and also not being registered with the Delhi Medical Council, in violation of the Section 15(6) of the Delhi Medical Council Act, 1997.


In light of the above, the Anti Quackery Committee, hereby, in exercise of powers conferred under section 10(h) of the Delhi Medical Council, Act, 1997 recommends that Shri Parveen Biswas be directed to stop practicing allopathy, forthwith, and to close down his clinic and Anti Quackery Committee also decided that the police be requested to register a FIR under Section 27 of Delhi Medical Council Act, 1997 alongwith relevant Section of IPC.


B) After deliberation, the Committee members feel that to curb the menace of quackery following point to be adopted:-


- i) The Registered doctors should be encouraged to lodge complaints against unauthorized and unqualified practitioners, of allopathy in the format to be produced for this purpose.
- ii) Information regarding Anti-Quackery Closure Orders passed by the Council should be publicised.
- iii) Advertisement should be published for awareness of doctors and general public to curb the practice of Quackery.
- iv) Directorate General of Health Services (DGHS), Govt of NCT of Delhi, be requested to convene a meeting of all CDMO's to discuss Anti-Quackery issues including inspection reports.
- v) Meeting of Nodal Officers of Branches of Delhi Medical Association be convened.
