However, since at the time of passing of the aforementioned order, Dr. Govind Anoop Raj did not hold valid registration with Delhi Medical Council, as his name already stood deleted w.e.f. 19<sup>th</sup> May, 2017 under Delhi Medical Council registration No.15302, on account of non renewal, no punishment in terms of warning or suspension of registration was inflicted on Dr. Govind Anoop Raj. It is noted that subsequently, Dr. Govind Anoop Raj had renewed his registration with Delhi Medical Council. In view of the fact that Dr. Govind Anoop Raj had renewed his registration with Delhi Medical Council and the Delhi Medical Council in its order dated 19<sup>th</sup> May, 2017 has indicted Dr. Govind Anoop Raj for professional misconduct; this matter was taken up for determining the punishment to be inflicting upon Dr. Anoop Raj., was confirmed by the Delhi Medical Council.

The Council also confirmed the punishment of warning awarded by the Disciplinary Committee to Dr. Anoop Raj (Dr. Govind Anoop Raj, Delhi Medical Council Registration No.15302).

The Council also confirmed the punishment of warning awarded by the Disciplinary Committee to Dr. Nabeela Khaliq (Delhi Medical Council Registration No.82070).

The Council further confirmed the punishment of removal of name of Dr. Abdul Khaliq (Delhi Medical Council Registration No.16900) for a period of 90 days awarded by the Disciplinary Committee.

The Council further observed that the Order directing the removal of name from the State Medical Register of Delhi Medical Council shall come into effect after 30 days from the date of the Order.

This observation is to be incorporated in the final Order to be issued. The Order of the Disciplinary Committee stands modified to this extent and the modified Order is confirmed.

The Secretary informed that there are no minutes of the Anti Quackery Committee of the Delhi Medical Council on which discussion is required, as no meeting of the Anti Quackery Committee of the Delhi Medical Council had been convened.

**5. To discuss about the Minutes of the Finance Committee.**

The minutes of the meeting of the Finance Committee of the Delhi Medical Council held on 18<sup>th</sup> February, 2020 (appended herewith as annexure 'B') which were circulated to the members present, were confirmed.

**6. To discuss the development in space allotment at DMRC IT Park, Shastri Park, Metro Station.**

The minutes of the meeting of the Land & Building Committee of the Delhi Medical Council held on 04<sup>th</sup> February, 2020 (appended herewith as annexure 'D') which were circulated to the members present, were confirmed.

**7) Any other item with permission of Chair.**

- (i) Dr. Vinay Aggarwal, Member raised the issue that the Assistant Secretary, Delhi Medical Council, Mr. L.D.S. Uppal who also have the legal qualification be authorized to lodge the complaint in the Court of Metropolitan Magistrate and also be authorized to represent in the Court Case as nominee of Registrar on behalf of the Delhi Medical Council with the assistance of an Advocate. Council members approved of the same.
- (ii) Issue of Foreign Medical Graduate to first complete 1 year Internship in India before granting permanent registration :- After a lot of deliberation it was decided by Council that the foreign medical graduates are required to undergo one year internship before getting the permanent registration essentially for the following reasons:
  - (a) To learn and gain clinical experience and exposure about the epidemiological and clinical profile of the country.
  - (b) To learn and understand regional language, culture of local community; and
  - (c) To learn and get exposure on the unique public health care delivery and referral system prevailing in the country.

Further, it is pointed out that, with the medical qualification acquired by the doctors they are not qualified to practice even in China, the country from where they acquired their medical degree one has to pass National Medical Licensing Examination (NMLE), which consists of a clinical skill test and general written test. It is also understood that all the medical graduates from China are returning to India without qualifying this test, which means the foreign graduates from China are not even qualified to practice in the said country.

**The council after due deliberations has decided that the foreign medical graduates from China, Bangladesh, Mauritius, Philippines, Russia are, therefore, required to undergo one year internship before getting the permanent registration on the basis of facts above. The above decision is exempted for foreign medical graduates who have completed MBBS from Nepal and thereafter completed one year Internship from Nepal as Nepal has earned a high rank in the world for having top-notch medical institutions offering MBBS and other medical degree courses.**


